Procurement of Goods and Services from M/s Sri Lanka State Trading (General) Corporation Ltd on a Single Source Quotation basis by Public Sector Institutions.

Ref: Decision of the Cabinet of Ministers No. 25/1920/817/025-IV dated October 21, 2025

As per the decision of the Cabinet of Ministers referred to above, approval was granted for all Public Sector Institutions to procure goods and services from M/s Sri Lanka State Trading (General) Corporation Ltd on a "Single Quotation" basis, up to a ceiling of Rupees Ten Million (Rs.10 Mn). The validity of this approval lapse on October 20, 2026.

The approval of the Cabinet of Ministers read together with the concurrence of the National Procurement Commission, M/s Sri Lanka State Trading (General) Corporation Ltd, has been exempted from the requirement to submit a Bid Security or Performance Security on submission of Bid documents /quotation and on acceptance of Contract respectively. However, M/s Sri Lanka State Trading (General) Corporation Ltd shall submit a Bid Securing Declaration, as specified in the Procurement Guidelines – 2024 on Goods, Works and Non-Consultancy Services.
