

As our government approaches the end of its first year in office, I appreciate this opportunity to issue a message to the progress report of programmes implemented in 2025 by the Ministry of Trade, Commerce, Food Security and Cooperative Development in the journey towards "A Thriving Nation—A Beautiful Life", the aspiration of millions of people of the country.

During the year, the Ministry has implemented a comprehensive suite of vital measures aimed at solidifying the foundation of a sustainable and equitable national economy. Driven by our government's development priorities, our primary focus was to promote just trade, ensure food security, improve consumer protection and revitalize the cooperative sector as a pillar of the participatory development.

In the trade and commerce sector, initiatives have been launched for modernizing trade environment, regularizing regulatory frameworks and optimizing market efficiency. Measures were also taken for the expansion of opportunities for small and medium scale enterprises, encouraging local value addition and safeguarding consumer needs through an enhanced monitoring and enforcement mechanisms. Rebranding the Cooperative Wholesale Establishment (CWE) as National CWE, modernizing and expanding the retail outlet network of Lanka SATHOSA enabling it to be to be more competitive can be cited as some of the measures initiated for further reinforcing these processes,

Ensuring food security remains as a core objective of our mission. The Ministry has commenced an extensive national food security strategy geared towards fostering self-sufficiency, minimizing post-harvest losses and stabilizing the price of essential commodities. Foundation has been laid to bring all Dedicated Economic Centers of the island under a single administrative structure strengthening collaboration amongst producers, traders and provincial administrative units thus guaranteeing the availability of consumables at prices affordable to all citizens.

The Cooperative movement has been reestablished as a tool for community based development. The Ministry is developing a new National Cooperative Policy, with support from national and international partners, to foster the creation of professionally managed, self-sufficient, and innovative cooperative enterprises. A three-year program has been launched at the provincial level to establish 1,000 production cooperatives in agriculture, fisheries, dairying, handloom textiles, and small industries, with the goal of boosting productivity and creating rural employment. Necessary steps have already been taken to develop Polgolla Cooperative College into an institution offering degrees in cooperative subjects by merging with a foreign university within the next three years, and to establish it as the National Cooperative Development University of Sri Lanka by 2030.

The achievements of our first year underscore the shared commitment of our institutions, officials, and stakeholders to building a just, resilient, and people-centered economy. As we proceed with the next phase of our priorities, I am confident the Ministry will remain dedicated to providing the necessary capabilities to achieve the national vision of 'A Thriving Nation - A Beautiful Life,' fostering economic justice, sustainable production, and social well-being for all citizens.

#### Towards food sovereignty trough food security...



It is a privilege to contribute this message to the Ministry of Trade, Commerce and Food Security's 2025 Progress Report, which chronicles the achievements of the current administration's inaugural year under the national policy framework of 'A Thriving Nation - A Beautiful Life'.

Over the past year, we have prioritized enhancing the efficiency of trading systems, stabilizing food supply chains, and empowering producers and traders to drive national economic growth through the

trading sector

To fortify local trade networks and foster fair market competition, we revived the previously closed Cooperative Wholesale Establishment, enabling its re-entry into the wholesale sector. Concurrently, plans are underway to launch a distribution network for essential food items through new National Sathosa Wholesale Trading Centers across several provinces within the next year. A recent key achievement was the reopening of the Vavuniya Dedicated Economic Center after a decade, which now facilitates the bulk supply of agricultural products from the Vanni District to the Dambulla Economic Center and other parts of the island. Following the reopening of the Jaffna Economic Center, the wholesale supply of agricultural products like red onions, chilies, and bananas has resumed from the Jaffna district to the Southern Province. In parallel, our Ministry has worked to strengthen consumer protections by streamlining the Consumer Services Authority, thereby mitigating market monopolies and ensuring access to quality products. We have also issued new guidelines to enhance the effectiveness of the Department of Measurement, Standards and Services. These policy measures, designed to stabilize the prices of essential goods, have notably boosted public trust in the Ministry.

In the area of food security, the Ministry focused its intervention on enhancing local production and guaranteeing equitable access to safe, nutritious food. The Ministry has since initiated the development of a joint mechanism involving Lak Sathosa, the Cooperative Network, and the National Sathosa to ensure the continuous flow of essential commodities across the country.

The Ministry's success in this first year reflects the collective effort and dedication of government officials, provincial administrations, cooperatives, and private sector partners. Their contribution was instrumental in ensuring the effective implementation of our policy initiatives at the ground level.

Moving forward, our strategic focus will be to strengthen institutional coordination, advance the digital transformation of trade and market management, and ensure all our initiatives contribute to a stable, fair, and inclusive economy. Guided by the principles of 'A Thriving Nation - A Beautiful Life,' we remain resolute in our commitment to securing lasting prosperity and food sovereignty for all Sri Lankans.

#### A people centred economy and a cooperative culture...



I am honored to present this message for the 2025 Progress Report of the Ministry of Trade, Commerce, Food Security and Cooperative Development. This report highlights the significant progress made during the current government's first year in realizing the vision of 'A Thriving Nation - A Beautiful Life'.

Under a new policy direction, the Ministry has initiated significant efforts this year to revitalize Sri Lanka's cooperative movement, which has served as a key player in the rural economy for more than a decade. Our goal is to foster

self-sufficient, people-centric institutions. Specifically, I would like to mention the crucial steps we have taken to strengthen this network through cooperative policy reforms, institutional restructuring, and leadership development.

A major milestone has been the appointment of an expert committee to review the National Cooperative Policy and propose how cooperatives should evolve in the coming decade, a process informed by wideranging stakeholder consultations. Through this policy, our Ministry aims to reposition cooperative societies and associations as productive economic enterprises capable of competing in modern markets, while still upholding the principles of democracy, equality, and social solidarity, in line with the International Co-operative Alliance's Charter.

To enhance productivity and market reach, a new program was launched this year to revive dormant cooperative societies, particularly in the agriculture, dairy, fisheries, and handloom textile sectors. A key step involved merging all provincial-level dairy producers' cooperatives into a single network to launch four main products under the 'CoopFresh' brand. The Ministry was able to facilitate essential training programs, factory modernization, and foreign training courses for this initiative, thanks to assistance from the Government of India.

Additionally, this year, we initiated a program to establish 1,000 agricultural production cooperatives across all nine provinces of the country. The Polgolla Cooperative College has already begun training the directors and employees required to successfully run these cooperatives. Future agreements have been signed with Lak Sathosa and National Sathosa, in addition to private buyers, to purchase the agricultural crops produced. This strategy has minimized market intermediaries and laid the foundation for providing goods to consumers at a reasonable price.

The Ministry plans to upgrade the Polgolla Cooperative College to a degree-conferring institution in cooperative studies within three years through an association with a foreign university. The Ministry has decided to seek UGC approval to formally establish it as the National Cooperative University of Sri Lanka by 2030.

In the coming year, we hope to further modernize the cooperative system, promote youth and women's participation, and build strong relationships with global cooperative networks. In line with the principles of 'A Thriving Nation - A Beautiful Life', our Ministry hopes to transform the cooperative movement into an institution that helps build a strong rural economy that is fair, resilient, and prosperous for all, while uplifting the lives of people in every community in the country.

## Improving a Trade Enabling Environment, Safeguarding Consumers and Ensuring Food Security...



The core purpose of the Ministry of Trade, Commerce, Food Security and Cooperative Development is to strengthen the national trade ecosystem, ensure food security, enhance consumer protection and revitalize the Co-operative sector in line with the national policy framework of 'A Thriving Nation - A Beautiful Life'. Accordingly, the Ministry is focusing to deliver effective policies and measures, addressing immediate trade and food security concerns while laying the foundation for a more efficient, resilient and productive trade and food security system.

During 2025, the Ministry moved with multiple challenges, including price volatility in essential commodities, climate-related disruptions to production, disturbances in domestic supply chains and the need for stronger regulatory enforcement across markets. Despite these challenges, significant progress was achieved in market stabilization through tariff revisions, the imposition of maximum retail prices on selected products, where essentially necessary, strengthened monitoring, and coordinated interventions to ensure uninterrupted availability of essential food items. Major institutional reforms were advanced with the reestablishment of the Co-operative Wholesale Establishment (CWE), the reactivation of Dedicated Economic Centers in Kilinochchi, Jaffna and Vavuniya, and the incorporation of National Agri Market Services Ltd for management of the Dedicated Economic Centers to ensure a tradeable infrastructure and environment for farmers, traders, and consumers. Additionally, the Ministry provided considerable guidance on key policy fronts, particularly through the Food Security and Policy Committee.

Progress in national trade policy remained a central component of the Ministry's mandate. A series of reform measures were also operationalized to improve the trade enabling environment, particularly, operationalization of anti-dumping and countervailing measures, registration of geographical indications, commencement of digitization of intellectual property documents, the completion of the fifth World Trade Organization (WTO) Trade Policy Review of Sri Lanka in 2025, etc. Furthermore, bilateral engagements through Joint Economic Commissions and other mechanisms with key trading partners were strengthened to secure market access, protect export competitiveness and support broader economic integration. In the area of food security, efforts were intensified to ensure the availability and affordability of essential food commodities. The Ministry also advanced a comprehensive agenda to modernize the Co-operative sector. This included progressing on legal reforms, reviving dormant Co-operatives, launching new provincial-level production Co-operatives and commencing capacity-building.

Looking ahead to 2026, the Ministry will continue to build on these achievements by accelerating the transformation of trade and market environments, improving supply chain efficiency through the establishment of interlinkages, expanding food security initiatives, and advancing trade negotiations. Further priorities include completing the Co-operative sector reestablishment, expanding trade facilitation services, advancing export and market access facilitation mechanisms, and enhancing institutional governance under the Ministry.

I extend my sincere appreciation to the Honourable Minister and two Honourable Deputy Ministers for their leadership and guidance. I also convey my gratitude to all officials and staff of the Ministry and heads and officials of institutions for their dedicated and untiring contribution towards achieving our institutional responsibilities.

#### 01. Vision, Mission, Objectives & Functions

#### 1.1 Vision

"Sustainable developed Sri Lanka"

#### 1.2 Mission

"Establishing, maintaining, and monitoring a national trade policy in line with local as well as international standards, which ensures the equality and rights of manufacturers, traders, suppliers of measurement services or other services, whilst ensuring leadership in the trade sector, performing service and monitoring activities, obtaining new market opportunities entering in to bilateral, multilateral, and regional trade agreements, contributing to ensure a higher life standard enhancing the quality of consumer items and services of Sri Lankans."

#### 1.3. Objectives

- Applying custom tariff policy as a tool for controlling the market behavior so as to secure
  the rights of local producers and consumers through a national trade policy and
  encouraging exports by way of granting tax concessions to local producers in order to
  induce productions.
- ii. Maintaining the cost of living at the minimum possible level maintaining the prices of essential items at such occasions where the prices of goods at the markets are escalating.
- iii. Providing necessary guidance to implement relief programmes for the benefit of consumers through the government institutions such as Lanka Sathosa, Co-operative Development Department, Co-operative Societies and Associations etc. at national level.
- iv. in an open market environment ensuring the application of measurement standards for the benefit of trading community as well as consumers.
- v. Enhancing legal framework with infrastructure facilities to maintain buffer stocks of essential items within the country to assure food security.
- vi. Providing guidance to the Consumer Affairs Authority for the legal activities relevant to safeguard consumer.
- vii. Preparing mechanism to maintain a data base relevant to the institutions under the Ministry, update such data bases, and make links with external information providers.
- viii. Providing guidance to implement the measures relevant to protect the proper standards of local products and export items.
  - ix. Making contribution to maintain welfare processes to encourage children for higher education.
  - x. Making directions to implement conservation process for the protection of national intellectual properties.
  - xi. Guiding for accreditation services conforming to the national and international standards

- xii. Establishment of the institutional background and encouragement of connected institutions in order to protect and promote the economic and commercial interests of Sri Lanka and encourage the exporters for opportunities in international market
- xiii. Providing necessary facilities and coordination in signing multilateral and bilateral trade agreements with various countries.
- xiv. Providing necessary directions for legal coordination in relation to Generalized System of Preferences (GSP), NMTR, Free Trade Agreements (FTA) and Regional Trade Agreements (RTA) of Sri Lanka

#### 1.4 Functions

- i. Formulation of policies in relation to the subject of trade in line with the national policies implemented by the Government.
- ii. Formulation, implementation of subjects, functions and related policies of the Departments, State Corporations and Statutory Institutions under the Ministry and carrying out follow up actions and evaluation in this regard.
- iii. Formulation of National Trade Policy and taking action to coordinate the institutes relevant to the implementation of such policy.
- iv. Creating competition in the market for ensuring the rights of consumers, formalizing internal trade and safeguarding consumers, supervising the market, conducting raids and raising awareness amongst traders and consumers.
- v. Performing the role of a mediator in order to contain fluctuation of prices in the local market.
- vi. Encouraging and facilitating institutions to identify new export opportunities in the world market and explore opportunities for new bilateral, multilateral and regional agreements.

## **Chapter Two**

## **Achievements**

#### 02. Achievements

- 2.1 Carrying on necessary coordination required for obtaining the approval of Cabinet of Ministers subsequent to the submission of policy decisions required for food security to the Food Policy and Safety Committee.
  - i. Guiding the activities of the CWE in relation to activities associated with obtaining pledge loans for the purchase of paddy under the paddy purchasing programme of the government for the Yala Season of 2025.
  - ii. Having obtained the approval of the Customs to release a stock of 3,600 kilograms of turmeric recommended as suitable for consumption by the Food Control Administration Unit, action was taken to hand over the stock to the CWE upon the recommendation of the Sri Lanka Standards Institute.
  - iii. Carrying on preliminary activities to fix a reasonable price for the purchase of big onions of the Yala Season of 2025 by the CWE and the private sector.
  - iv. Guidance and coordination for the purchase of potato harvest at a reasonable price by the CWE and the private sector and sell to the consumer at a reasonable price.
  - v. Introduction of a tax levying process on the import of seasonally produced goods that will be operationalized in 2026.
- 2.2 Appointing Steering Committees and Technical Committees for the initiation and establishment of the National Quality Council.
- 2.3 Convening subcommittees in relation to the implementation of the National Tariff Policy and discussing tax amendments in respect of each sector.
  - Establishing a sub-committee under the chairmanship of the Secretary to the Ministry of Trade, Commerce, Food Security and Cooperative Development, covering the sectors of agriculture, plantation industries, fisheries and industry, to facilitate the implementation of the National Tariff Policy, including the modification or updating of tariffs in accordance with the provisions of the National Tariff Policy of Sri Lanka.
- 2.4 Coordinating relevant institutions to ensure that essential food items are supplied to the consumer without shortages and carrying out the necessary coordination activities to ensure adequate supply of rice varieties that are observed to be in short supply in the market.
- 2.5 Offering guidance to provide necessary relief to consumers by coordinating the setting of maximum retail prices and maximum wholesale prices for essential consumer goods where necessary.
- 2.6 Securing the Cabinet approval for the reestablishment of the Cooperative Wholesale Department.

Taking measures to secure approvals for the reestablishment of the CWE and resume its business activities on the basis of a feasible business plan having cancelled the previous Cabinet decision for its liquidation.

#### 2.7 Multisector Action Plan for Nutrition (MSAPN)

The first pilot programme on MSAPN was launched in September in the Ratnapura district and action is being pursued concurrent thereto for the conduct of pilot programmes in the Batticaloa and Nuwaraeliya districts too in the future.

#### 2.8 Establishing "National Agri Market Services Limited"

A state company named "National Agri Market Services Limited" was established to operate and manage the 18 Special Economic Centers currently scattered across the country efficiently and effectively under one business model.

By establishing this company, it is expected to expand the market to farmers, traders and consumers and broaden the marketing and purchasing facilities.

- 2.9 Implementing necessary activities to stabilize the market to address the shortage of production in the salt industry caused by climate change occurred in the country after 30 years.
- 2.10 Making necessary arrangements to impose import taxes for potatoes and big onions with a view to protecting local onion and potato farmers.
- 2.11 Necessary guidance for carrying out operational activities of Dedicated Economic Centers at Vavuniya and Jaffna.
- 2.12 Formulating and enforcing a new legal framework for the restructuring of the cooperative sector and establishing a new legal framework wherethrough for establishing manufacturing cooperative societies and regulating cooperative societies engaged in financial activities.
- 2.13 Coordination and holding discussions to secure mutual tariff concessions between the United States of America and Sri Lanka.
- 2.14 Registration of geographical indicators in compliance with the applicable laws and regulations has been commenced from the year 2025.
- 2.15 Carrying on necessary coordination activities for the application of provisions for executing regulations relevant to the Antidumping and Countervailing Act.
- 2.16 Implementing the Based Best Practices of Agri Food Sector Development Project in partnership with the Ministry of Health and Media in order to improve qualitative infrastructure facilities for food security.

#### iii. Affairs of the Establishments Division

- a) All establishment activities of the Ministry are carried out in a coordinated manner with other institutions. This work has resulted in the submission of approximately 64 ministerial papers to the Cabinet concerning the Ministry and the institutions under its purview.
- b) The Public Service Recruitment Review Committee of the Prime Minister's Office has approved the recruitment of employees to fill vacancies in the institutions under the Ministry, including the Consumer Affairs Authority, Sri Lanka Accreditation Board for Conformity Assessment, Lanka Sathosa Limited, Cooperative Wholesale Establishment, Sri Lanka Government State Trading (General) Corporation, National Institute of Cooperative Development, National Intellectual Property Office of Sri Lanka, Department of Registrar of Companies, Department of Measurement Units, Standards and Services, and Lalith Athulathmudali Mahapola Higher Education Scholarship Trust Fund, and the relevant recruitment activities are currently underway.

Further, as per Cabinet Decision No. 25/1579/817/030 dated 08.09.2025, the Cabinet has approved the extension of the period of service for 39 approved posts from 14.08.2025 to 13.08.2026.

#### iv. National Evaluation Policy of Sri Lanka

Proposals for projects seeking allocation of funds from the 2025 State Budget were requested, adhering to the guidelines set out in Project Management and Monitoring Circular No. 01/2024, which outlines "Responsibilities and Roles of All Government Institutions for the Implementation of the National Evaluation Policy of Sri Lanka".

As a key initiative under the National Evaluation Policy Program, the expansive, 5000 MT temperature-controlled warehouse facility at Dambulla facility which is under the purview of the Food Commissioner's Department functioning under our Ministry has been selected for evaluation for the year 2025 and procurement activities are currently underway to select a specialist consulting firm required for carrying out an independent evaluation and the relevant Reference Group and Management Group have already been identified. This critical oversight project is budgeted at approximately Rs. 2.5 million.

#### 3.2 Department of Commerce

#### i. Multilateral Affairs Division

#### a) Fifth Trade Policy Review of Sri Lanka

The Trade Policy Review (TPR) is a crucial function of the World Trade Organization (WTO) which serves to monitor and evaluate the trade policies and practices of member nations, promoting a transparent, accountable, and thorough understanding of global trade dynamics. TPR is a periodic assessment and reports are published by the WTO to provide insight into the trade policies and practices of member countries. This helps other members understand the trade practices of the country under review and initiates a dialogue on potential improvements.

Sri Lanka's last trade policy review as a WTO member was conducted in 2016 and the next review is scheduled to be held on 15 and 17 October 2025. For this, the Department coordinated with the relevant institutions (ministries, departments, boards, etc.) to provide detailed information related to the questionnaire sent by them to initiate the work on the WTO Secretariat report. Furthermore, the report to be prepared by the Government of Sri Lanka was also prepared and sent to the WTO Secretariat. Answers are currently being provided for more than 250 questions referred to by other WTO members regarding Sri Lanka's trade and investment policies.

#### b) Enforcing trade remedy laws

Basic regulations required for the enforcement of the Anti-Dumping and Countervailing Tax Act, No. 2 of 2018 were promulgated. Accordingly, the manner a local producer should make an application to the Director General of Commerce as to an anti-dumping or countervailing duty investigation and the procedure for entering into a price undertaking were published in Gazette Notification No. 2429/32 dated 27.03.2025. The official notification to the WTO regarding the Trade Remedy Legislations of Sri Lanka, the Anti-Dumping and Countervailing Tax Act, No. 2 of 2018 and the Safeguard Measures Act, No.3 of 2018 was made in May 2025. Similarly, the notification of the Trade Remedy Unit at the Department of Commerce for the enforcement of these laws to the WTO was made by the Department of Commerce. A media briefing too was held to make the relevant stakeholders aware of the enforcement of these laws and two programmes were conducted with the intervention of sectoral committees of the Ministry of Industries and Enterprise Development to educate local producers. The Department of Commerce conducted 4 awareness raising programmes for public officials and local manufacturers with the participation of WTO resource persons.

#### c) WTO Agreement of Fisheries Subsidies

In order to accept the WTO Fisheries Subsidies Agreement, Sri Lanka submitted its letter of acceptance in August 2025 as a country supporting the ratification of the WTO Fisheries Subsidies Agreement. The agreement represents a significant milestone in global efforts to promote sustainable fisheries management by establishing binding rules to eliminate harmful subsidies offered by governments of some member countries (fuel, modernization of vessels, repayments, etc.) and by preventing illegal, unregulated and unreported fishing that lead to overfishing and depletion of stocks. The Department of Commerce in collaboration with other line ministries of Sri Lanka carried out all activities from year 2022 required for the ratification of this agreement.

#### ii) Bilateral Affairs Division

### a) Eighth session of the Joint Commission for Economic and Trade Cooperation between Sri Lanka & China

The eighth session of the Joint Commission on Economic and Trade Cooperation between Sri Lanka & China was held successfully in Colombo with the participation of key stakeholders of both parties. The two parties were involved in in-depth discussions and reached agreement on promoting the "belt and road" development strategy, strengthening trade and investment cooperation and maintaining multi-industrial trade system. Two memoranda of understanding to set up a working group on trade facilitation and on strengthening industrial and supply chain cooperation.

## b) Third session of the Joint Committee for Sri Lanka –Turkey Economic and Technical Corporation (JCETC)

The third session of the Joint Commission on Economic and Technical Cooperation between Sri Lanka & Turkey was held successfully in Colombo with the participation of key stakeholders of both parties. The session strengthened bilateral cooperation in key sectors including trade, investment, tourism, health, technology and maritime affairs. It provided a platform for Turkey to promote Sri Lankan exports, explore export diversification opportunities and encourage Turkish investments in priority sectors. The two sides also agreed to sign Memorandums of Understanding (MOUs) in the near future on education, investment, health, culture, industrial cooperation and technological cooperation. The agreed conclusions are expected to improve market access, strengthen business-to-business linkages, and support Sri Lanka's export growth strategies.

## c) Quarterly Working Group Meeting under Sri Lanka – Australia Trade & Investment Framework Arrangement (TIFA)

Two quarterly meetings of the Working Group established under the Australia-Sri Lanka Trade and Investment Framework Arrangement (TIFA) were held in March and August 2025. These sessions provided an opportunity to review ongoing cooperation and discuss future actions to accelerate existing investment proposals, discuss progress on market access issues and technical assistance. The two sides also reviewed new measures to strengthen trade and investment relations. Sri Lanka also presented twelve new proposals for consideration

by the Australian side. Australia agreed to communicate these proposals in consultation with its relevant agencies.

## d) Joint Commission on Sri Lanka –Pakistan and Sri Lanka –Iran Trade & Economic Corporation

As part of the preparation for the upcoming sessions of the abovementioned joint commission, the Department of Commerce held discussions with the line ministries and Sri Lankan stakeholders.

#### e) Japan – Sri Lanka bilateral relations

The Department of Commerce has made significant contributions to the preparation of the Draft Master Plan for the Sri Lanka-India Export-Oriented Industrial Corridor, which is being prepared jointly by Sri Lanka and Japan. Japan is acting as a co-facilitator and the Department of Commerce has provided relevant data and suggestions regarding trade and commercial activities in the preparation of the plan.

#### iii) Regional Affairs Division

## a) Free Trade Agreement of Bay of Bengal Initiative for Multi-Sectoral Technical and Economic Cooperation (BIMSTEC)

Sri Lanka participated in the 22nd meeting of the Working Group on the Bay of Bengal Region's Multi-Sectoral Technical and Economic Cooperation (WGROO-BIMSTEC) held virtually in Dhaka, Bangladesh on 25 March 2025. The meeting discussed the draft of the Modernization of the Rules of Origin of Goods of the BIMSTEC Free Trade Agreement (FTA) and the Operational Certification Procedures (OCP) for those Rules. After extensive deliberations, the Working Group updated and revised the draft Rules of Origin of Goods for the BIMSTEC Free Trade Agreement.

#### b) Conference of Trade Ministers and Senior Officials of the Commonwealth

The Commonwealth Trade Ministers Meeting (CTMM) and an accompanying Senior Trade Officials Meeting (STOM) were held in Namibia in June. A Sri Lankan delegation, including the Minister of Trade and two senior officials from the Department of Commerce participated in the meetings. Discussions covered digital trade, trade facilitation, green trade, critical minerals, and strengthening the multilateral trading system, leading to the approval of the draft Outcome Statement and the Joint Commonwealth Statement. Initial implementation plans for the Trade and Investment Task Force were also approved, and the Commonwealth Model Law on Digital Trade was strengthened to support member countries.

#### iv) Trade Promotion Division

#### a) Handing trade inquiries

A total of 481 trade enquiries were managed by Commercial Officers, who furnished essential information and guidance to advance the promotion of Sri Lankan products internationally. The Department also referred 38 additional enquiries from local exporters and trade institutions to the officers for a thorough follow-up.

#### b) Rendering assistance for settling trade disputes

77 complaints were received from parties involved in disputes seeking observations for amicable settlement of import & export related disputes. The Department of Commerce serves as a facilitator for the settlement of trade disputes by facilitating amicable solutions for import & export related disputes amongst parties to the dispute.

#### c) Making recommendations for residential visas

Having reviewed applications of 87 foreigners involved in the trade and service sectors and 39 of their dependents, residential visa recommendation letters were issued.

#### d) Trade Ratio Quota Certificates issued for garments with India under Indo Sri Lanka Free Trade Agreement (ISFTA)

2,407 TRQCs were issued for 7.74 million shares.

## e) Issuing letters of recommendations for tariff exemptions for Basmati rice quota under Pakistan and Sri Lanka Free Trade Agreement

Under Pakistan Sri Lanka Free Trade Agreement 09 letters of recommendations for tariff exemptions were issued for the importation of 362 metric tons of Basmati rice.

#### f) Organizing trade fairs/exhibitions/ ceremonies

#### vi. Research and Planning Division

#### a) Organizing information sessions for exporters

An information session was organized to educate exporters and private sector companies on the EU GSP+ scheme and the UK's Developing Countries Trading Scheme (DCTS). Officials from the Department of Commerce delivered a technical presentation which offered valuable knowledge to exporters and private sector representatives.

More than 80 Sri Lankan private sector exporters participated in the event, providing them with valuable insights into navigating the intricacies of EU and UK trade regulations within the context of a modern global marketplace.

## b) Organizing regional level awareness programmes for small and medium-scale sized exporters

The Department of Commerce has initiated a series of island-wide awareness sessions for small and medium-sized enterprise (SME) exporters, aiming to identify small and medium scale enterprises suitable for entry into foreign markets. As part of this initiative, two workshops have already been successfully organized, reaching over 100 SMEs across the Gampaha and Galle districts.

## c) Organizing a series of webinars with Commercial Officers for educating exporters on foreign markets

Five webinars were organized targeting overseas markets i.e. the US, UK, India, Italy and Germany. Commercial officers from the respective countries were involved as resource persons to enhance exporters' understanding of the relevant markets. Over 100 Sri Lankan private sector exporters, government officials and officials from chambers of commerce attended each webinar.


#### 3.3 Lanka SATHOSA limited

#### i. Progress from 01.01.2025 to 30.09.2025 Business Strategies/Operational Development

From January to September 2025, Lanka Sathosa recorded a turnover of Rs. 37.5 billion. The company achieved this financial success while operating without additional debt, strengthening its cash flow, and increasing its gross profit margin. These positive results were attributed to enhanced operational efficiency, which was a result of a proper business strategy and the implementation of key performance indicators (KPIs) and effective monitoring methods.

#### ii. Cost minimization strategies

Lanka Sathosa implemented significant cost reduction strategies to ensure the optimal utilization of resources. Management focused on identifying loss-making business outlets, conducting detailed operational analyses, and taking necessary actions to reverse or minimize those losses. Sales performance was continuously evaluated, enabling management to take prompt measures for profit improvement, loss minimization, and overall profitability increases. Consequently, for the first nine months of 2025, the company successfully reduced its combined sales, distribution expenses, and administrative costs by Rs. 385 million, compared to the corresponding period of the previous year.

Last year, LSL was able to pass on that benefit to customers by reducing the Maximum Retail Price (MRP) by an average of 17%.

#### iv. Reduction of interest rates

To mitigate the impact of the overall financing cost, Steps were taken to consult with financial institutions and successfully reduced existing interest rate from over 12% down to 9%. This strategic move reduced the company's average monthly overdraft (OD) interest cost from Rs. 60 million to Rs. 42.7 million by September 2025, resulting in a total savings of Rs. 108 million as of that month. These measures ultimately led to increased profitability, improved cash flow, and reduced pressure on working capital.

#### v. Negotiations with suppliers

A plan was successfully negotiated with creditors to extend loan maturities, enabling Lanka Sathosa to pay off its outstanding debts. This strategic move secured more favorable pricing terms, which will help the company reduce procurement costs and improve overall profitability. By reducing immediate cash outflows, the company has also positively impacted its short-term liquidity position.

#### vi. Improved Return Management and Stock Loss Recovery Policy

To minimize costs associated with return management and stock loss recovery while increasing liquidity, a formal system has been developed and implemented. Steps have been taken to recover identified stock loss balances from the responsible employees. A portion of these recoverable balances has already been collected, with the remainder currently being processed. Furthermore, a dedicated recovery committee has been established to manage these efforts. Recoveries have been initiated from the responsible parties, and necessary disciplinary actions including the issuance of charge sheets and formal investigations are being pursued regarding the stock losses.

#### vii. Training and Development Programs

Several training programs were conducted regionally to enhance the skills and capabilities of employees. These technical sessions helped to improve the overall efficiency and service quality of the Lanka Sathosa outlet network.

#### viii. Other key sustainable initiatives

Fixed assets verification was initiated through an external audit firm to properly update the Fixed Assets Register.

An ERP system audit was initiated by an external audit firm to investigate the irregularities and quantitative errors in the computer system.

Document security in the institution was established by introducing a Document Management system.

The process of selecting a service provider to conduct a forensic audit to re-examine the irregularities in the transactions shown in the institution's past financial reports and accounts is in progress.

Sales were made more efficient by introducing a computer database system to quickly identify and repair fixed assets (refrigerators, generators, bottle coolers) in outlets.

Gratuity payments of 243 employees that were due for a long time were resolved under the correct methodology.

#### 3.4 Cooperative Wholesale Establishment

#### i. Purchasing paddy and converting purchased paddy into rice

The total quantity of paddy purchased during the period from 24th April 2025 to 17th July 2025 for the 2024/25 Maha season is 3,831,894 kilograms. The paddy is currently being converted into rice and distributed in the market for sale. Accordingly, about Rs. 145 million worth of rice has been released to the market. Four paddy purchasing centers have been established in Hingurakgoda, Rajanganaya, Nikaweratiya and Kaduruwela for the 2025 Yala season and paddy purchasing activities are currently underway.

#### ii. Establishing Wholesale Marketing Centres

CWE is moving forward with plans to establish new wholesale centers in Kurunegala and Matara to expand its reach. The initiative has received approval from the Department of National Planning, and the process is underway to obtain final approval from the Department of Public Enterprises. A consortium consultant has been appointed to oversee the project, and a competitive bidding process was initiated to select a construction service company. As the next step in this process, a technical evaluation of the received bids has been successfully completed. In a separate development, the Cooperative Wholesale Trading Corporation officially began operations at its stock collection and marketing center located within the Vavuniya Special Economic Center on September 03, 2025.

#### iii. Repairing Vehicles

The Cooperative Wholesale Trading Corporation owns 37 lorries that were acquired between 2014 and 2015. Many of these vehicles are currently in a condition unsuitable for driving. Six of the lorries are already undergoing necessary repairs, and an additional four have been identified as requiring immediate maintenance.

#### iv. Valuation of Property

The Cooperative Wholesale Trading Corporation has requested the Government Valuation Department to provide valuation values for 27 properties leased to other parties and the valuation work for 14 locations has been largely completed. The remaining valuations are still ongoing. New lease agreements are to be signed based on the completed valuation reports.

The industrial calibration income up to September 2025 is Rs. 5.71 million, the equipment model approval income is Rs. 0.88 million and the weighing and measuring instrument verification income (Rs. million) is Rs. 313.90 million.

#### 3.8 Dedicated Economic Centers

The programme for establishing Dedicated Economic Centers (RECs) program in Sri Lanka was initiated in 1998 and its main objective is to ensure fair prices for the products of rural farmers and producers as a marketing and promotion strategy and to create an island-wide distribution network to provide opportunities for consumers in the island to obtain goods and food commodities easily and at reasonable prices. Currently, the necessary legal advice, follow-up and evaluation are being provided to maintain the proper functioning of the economic centers.

Accordingly, the functions executed are as follows.

- i. Appointment of trust members for management trusts.
- ii. Taking steps to prepare a common lease agreement for all economic centers regarding the leasing of business premises.

- iii. Assisting in resolving issues related to ownership of lands on which economic centers are located.
- iv. Initiating action to expand the composition of the Management Trust of economic centres.
- v. Calling for and inspecting annual accounts reports, annual accounts reports and reports of recovery of rent arrears of shops of economic centres.
- vi. Forwarding annual financial reports of economic centres to the National Audit Office and the Department of Public Finance.
- vii. Forwarding the answers received in respect of audit inquiries of economic centers to the National Audit Office.
- viii. Preparing responses to audit inquiries submitted in relation to economic centers in general.
- ix. Reactivating economic centres that remained inactive, (Jaffna. Vavumiya)
- x. Allocating provisions for economic centers for dedicated economic centres in which a management trust fund (Jaffna, Kilinochchi, Vavuniya, Batticaloa) for revenue and capital expenditure)
- xi. Inspecting and granting approvals for Action Plans 2025 and annual budgetary estimates 2025 of all Dedicated Economic Centres.
- xii. Examining procurement activities included in Action Plans of all Dedicated Economic Centres and granting approval for essential procurement activities.
- xiii. In terms of Cabinet decision No. CP/25/0774/817/02 dated June 03, 2025, the approval of the Cabinet of Ministers has been received for the incorporation of a limited liability company for the management of Dedicated Economic Centres. Accordingly, incorporating the said company and organizing board meetings thereof.

#### ii. Special activities carried out in the year 2025

#### (a) Implementing the project for digitizing intellectual property files

The project, a free service facility provided by the World Intellectual Property Organization (WIPO) to Sri Lanka, aims to scan and digitize no less than two hundred thousand physical files held at the National Intellectual Property Office (NIPO). This initiative is designed to make service delivery more efficient and to establish comprehensive online service facilities for the public.

To commence the project, an agreement was signed between the World Intellectual Property Organization and the National Intellectual Property Office on March 24 of this year, and the project will be implemented through a service provider selected by the organization. The current progress of this project, which is scheduled to be completed in the coming year, is 47%.

#### (b) Finalizing preliminary activities for accession to Madrid Protocol

The revised draft of amendments to bring about necessary changes to the Intellectual Property Act . to, enable Sri Lanka to accede to the Madrid Protocol, has been forwarded to the Legal Draftsman for final review with observations and concurrence from the World Intellectual Property Organization (WIPO) which oversees the Madrid Protocol. Following approval from the Attorney General and the Legal Draftsman, a Cabinet Memorandum is anticipated to be presented to Parliament this year to finalize accession.

#### (c) Facilities for the registration of Geographical Indications

Registering a product as a Geographical Indication (GI) can provide exporters with a competitive edge in international markets if the product's uniqueness is linked to its geographical origin. This year, the National Intellectual Property Office (NIPO) initiated the first-ever registration process for GIs in Sri Lanka and has so far received two applications. The NIPO is also planning a series of awareness programs to educate manufacturers and the business community about GIs and their benefits.

## (d) Promoting Intellectual Property

The subject of intellectual property play a pivotal role in the development of a country. The National Intellectual Property Office (NIPO) undertook a series of awareness programs across Sri Lanka to promote the use of intellectual property for economic development among inventors, entrepreneurs, and users. During the period from January to September 2025, a total of 13 awareness programs were successfully conducted, including five physical events. One notable event was the Intellectual Property Promotion Program held at the University of Jaffna.

#### (e) Formalizing the protection of copyrights

Copyright is a fundamental legal right granted to the creators of literary and artistic works. Its purpose is to protect the rights of authors, ensuring they receive economic benefits and due recognition for their creative efforts. Beyond benefiting individual creators, copyright law serves to promote continued creativity in literary and artistic fields and encourage investment in the creative spheres.

In conjunction with the celebration of World Intellectual Property Day in April 2025, the National Intellectual Property Office (NIPO) and the World Intellectual Property Organization (WIPO) collaborated on a two-day workshop in Colombo. The workshop featured international resource persons and aimed to educate Sri Lankan musicians, artists, and creators on intellectual property, the formal protection and commercial exploitation of their works, and the formalization of collective management organizations.

Work is currently underway in accordance with an Action Plan prepared in collaboration with WIPO to formalize the functioning and operations of these collective societies in Sri Lanka.

#### (f) Information Technology related improvements

As of 28.02. 2025, the National Intellectual Property Office (NIPO) has digitalized its correspondence process. All incoming letters for patents and industrial designs, along with all

outgoing correspondence from the institution to applicants, are now digitally entered into the Intellectual Property Administration System (IPAS).

The Global Brand Database, a database maintained by the World Intellectual Property Organization on trademark registration, began listing trademarks registered and published at the National Intellectual Property Office from April 2025.

A firewall has been successfully installed to bolster the security of the institution's network system. Furthermore, all necessary procurements have been completed to provide official email addresses to the officers. The institution is scheduled to commence the use of these official e-mail addresses from the beginning of November 2025.

#### 3.14 Sri Lanka State Trading (General) Corporation

- i. **Sales revenue** is reported at Rs. 5.7 billion which is the revenue from the general and special trading activities of the corporation.
- ii. **Gross profit** is Rs. 679 million and the gross profit ratio is 12%. This is a significant profit compared to the total sales revenue.

#### iii. Profit before tax

The corporation has earned Rs. 256.5 million as profit before tax in the year 2025.

#### iv. Special operations of the year 2025

#### a) Expanding product portfolio

Operating under the direction and guidance of the line Ministry of Trade, Commerce, and Food Security, Sri Lanka State Trading (General) Corporation Limited performed a number of special operations throughout the year 2025 as an importer and distributor to control consumer market shortages whenever the government required, ensuring the necessary supply of goods reached the public at reasonable prices in a timely manner.

When there was a shortage of salt in the market, salt was imported and distributed to the people expeditiously to address the shortage.

When there was a shortage of Sri Lankan rice in the country, rice was imported and distributed to the people through the Lanka Sathosa sales network at affordable prices without causing inconvenience to the government and the public.

In accordance with government policies, the distribution of animal feed, a special project aimed at uplifting farmers and the animal feed industry, was carried out.

#### b) Employee Development

To enhance the effectiveness and efficiency of its overall operational process, the institution has introduced Key Performance Indicators (KPIs). This initiative aims to increase the responsibility and focus of employees towards their tasks.

Measures have been taken for the introduction of a Human Resources Information System (HRIS).to stabilize staff management by systematizing all personnel data, ensuring that HR processes are carried out accurately and effectively.

In 2025, a series of external training programs and workshops were organized aimed at developing the knowledge, skills, abilities, and motivation of its employees.

Specifically, to enhance the product knowledge of sales department staff, Product Training and Factory Visits were organized, providing employees with new product information and a practical understanding of the production process.

### c) Strategic initiatives

Action was taken to upgrade the product portfolio by introducing new products and marketing campaigns were launched to improve revenue from existing products.

#### d) Administration and Compliance

Twelve (12) Board of Directors meetings and four (4) Audit Committee meetings were held during the year 2024/25.

#### i. Construction of Dambulla Temperature Controlled Storage Complex

The construction work of this project is currently in its final stage and upon completion, the formal handover of the project from the contractor to the Food Commissioner's Department is scheduled to take place.





# **Chapter Four**

# **Future Plans -2026**

#### 04. Future Plans -2026

#### 4.1 Ministry of Trade, Commerce, Food Security & Cooperative Development

- i. It is proposed to construct the Cooperative Square Building at a cost of approximately Rs. 07 billion in the year 2026 to bring the Ministry of Trade, Commerce, Food Security & Cooperative Development and institutions thereunder established in other buildings on the rent basis under one roof, enabling consumers to access the services delivered by each of these institutions without delay whilst facilitating direct supervision and coordination of the Ministry.
- ii. Starting in 2026, the operations of the Dedicated Economic Centers are planned to be implemented properly, under the legal framework of the newly established "National Agri Market Services Limited which was specifically created to manage these centers.
- iii. Developing a Competition Policy Framework required for the facilitation of activities through trade agreements and taking action to expand market accessibility to Sri Lankan products.
- iv. Establishing the National Quality Council.
- v. Developing a new legal framework for cooperative development in Sri Lanka, including producer cooperative societies and cooperative banks.
- vi. Developing eRoc 2 to meet the expectations of the cooperative sector and improve the ease of doing business.
- vii. Formulating a competition legal framework.
- viii. Developing a policy framework to facilitate trade agreements and expand market access for Sri Lankan products.
  - ix. Sri Lanka Thriposha Limited intends to focus on sustainable development, modernization, and diversification in 2026. The company's plans, which are supported by the government and ongoing collaborations with the World Food Programme (WFP), aim to ensure nutritional security of Sri Lanka and improve health of different community groups.

#### 4.2 Department of Commerce

- i. Providing technical assistance in negotiating Free Trade Agreements and Preferential Trading Agreements.
- ii. Participation in multilateral, regional and bilateral trade forums
- iii. Conducting Joint Trade and Economic Commissions.
- iv. Monitoring and reviewing the effective implementation of preferential and non-preferential agreements.
- v. Organizing trade delegations for Sri Lanka Expo 2026.

- vi. In 2026, the Department plans to focus on regional awareness programs.
- vii. Preparation for the 14th Ministerial Conference of the World Trade Organization. Liaison will be maintained with relevant government institutions to formulate Sri Lanka's intentions regarding the areas slated for discussion at the 14th Ministerial Conference.

#### 4.3 Lanka Sathosa Limited

#### i. Improving revenue and gross profit margin.

This will be done through increasing product availability and margins.

- Target Sales: Rs. 60 billion.

- Target Gross Profit Margin: 13.5%.

Strategic initiatives will be implemented to increase product availability and margins by focusing on high-performing and high-margin products.

#### ii. Outlet expansion strategy

An organized store expansion plan will be implemented to strengthen the market presence and improve customer access in the Northern Province, Eastern Province, Uva Province, and other regions of Sri Lanka.

New stores will be strategically established in areas with high sales trends and demands. The location selection process will be guided by thorough market demand analysis, consumer mobility patterns, and other technical factors to ensure optimal market penetration.

- iii. Initiate renovation works for the outlets with deficiencies to improve and strengthen the reputation and image of the institution.
- iv. Modernize the warehouses to increase the efficiency of the supply chain.
- v. Introduce a new ERP system to increase the overall administrative efficiency of the business.
- vi. Facilitate the marketing and sales of small and medium-sized enterprises directly to the end consumers.

#### 4.4 Cooperative Wholesale Establishment

- i. Expanding market opportunities by converting paddy purchased by the Paddy Marketing Board (50,000 metric tons of per season) into rice under the "National Sathosa" brand (PMB). In addition to the Lanka Sathosa outlet network, orders will be obtained from other supermarket chains.
- ii. Establishing wholesale trade centers covering 4-6 provinces. The primary objective is to improve the quality of life of the people by bringing quality products closer to the consumers across the island at low prices.

- iii. Updating the preparation of final accounts, bank reconciliations, and financial reports. Preparation and finalization of all final accounts, bank reconciliations and financial reports that are due for finalization and submission of final accounts, bank reconciliations and financial reports on a monthly, quarterly and annual basis.
- iv. Establishing a processing and packaging center by the Cooperative Wholesale Establishment. Purchasing local farm products such as turmeric, chili, pepper, green peas, chickpeas, and cowpeas and releasing them to the market after processing and, packaging. This initiative aims to serve two primary purposes: create a fair and stable market for local farmers and provide consumers with high-quality, non-toxic food products.

#### 4.5 Lalith Athulathmudali Mahapola Higher Education Scholarship Trust Fund

#### i. Preparing a database for scholarship recipients

A database has been created for approximately 300,000 students who completed their university studies with the support of Mahapola Trust Fund scholarships and are now engaged in various jobs and professions locally and abroad. The goal is to request these scholarship recipients to contribute to the Fund. To facilitate this, direct bank payment (online payment gateway) facilities have been established with the People's Bank. In the coming years, the Fund hopes to implement promotional programs through attractive outreach methods and a media campaign using newspaper advertisements and electronic media to encourage contributions.

#### ii. Reactivating Mahapola Online Lottery

Three previous efforts to launch the Mahapola Online Lottery three times in the past were unsuccessful due to various reasons. The Board of Trustees intends to launch a more transparent online lottery in the future to support the Mahapola Trust Fund.

#### iii. Resumption of Mahapola Educational and Trae Fair

The Mahapola founder, the late Lalith Athulathmudali, initiated the Education and Trade Fair in 1981/82 alongside the establishment of the Mahapola Fund and concept. The fair was subsequently discontinued for approximately 20 years. The Board of Trustees officially approved the resumption of the trade fair from 2023 onwards following a thorough study of the matter.

## 4.6 Sri Lanka Accreditation Board for Conformity Assessment

- i. Training and promotion of Reference Material producer scheme and Biobanking scheme.
- ii. Validation/Verification Division
  - a) Extend international recognition (IAF MLA) for ICAO-CORSIA, ISO 14067:2018

#### 4.7 Department of Measurement Units, Standards and Services

- i. Installing the central air-conditioning system in the National Measurement Laboratory.
- ii. Expanding the scope of the National Measurement Laboratory by establishing new measurement standards.
- iii. Making arrangements to have metrology as a subject of university curriculum.
- iv. Updating the Measurement Units, Standards and Services Act and regulations thereunder. This is aimed at boost the income from departmental services and regularize the services delivered by the department.
- v. Facilitating other institutions providing national quality infrastructure to acquire international recognition.
- vi. Creating an automatic network system- Estimated amount is Rs. 70 million. It is expected that the 25 district offices will be linked to the head office and that the trade database system will be developed to ensure accurate and reliable weighing and measurement services to the consumers.

## 4.8 National Intellectual Property Office of Sri Lanka

- i. Obtaining a building with sufficient space for the Intellectual Property Office.
- ii. Successfully completing the ongoing intellectual property file scanning project with the assistance of the World Intellectual Property Office.
- iii. Initiating preliminary work to establish an online payment system and online application submission facilities.
- iv. Upgrading the Industrial Administration System to its fourth edition.
- v. Amending the Intellectual Property Act to be in conformity with the Madrid Protocol.
- vi. Establishing Copyright Division and securing approval for scheme of recruitment.
- vii. Clearing the backlog of a large number of applications for trademarks, patents and industrial designs during the first two quarters (06 months) of 2026.
- viii. Organizing awareness workshops for commercial organizations at the provincial level to promote the registration of geographical indications.

#### 4.9 Consumer Affairs Authority

i. Finalizing the amendment of the Consumer Affairs Authority Act, No. 09 of 2003.

- ii. Offering the contribution of the Consumer Affairs Authority to make digital trading activities (e-commerce) more equitable.
- iii. Upgrading the consumer application interface to receive complaints/information.
- iv. Improving the quality of raids through training programs and quality-based performance evaluations.
- v. Enact legislation mandating the inclusion of cost components and tax components related to the goods mentioned in the bill on bills/invoices issued when purchasing goods and services, and making it mandatory for sellers to issue bills to consumers when purchasing goods.
- vi. Conducting a study on the fees charged in addition to the maximum retail price marked on the product when making payments by credit card or any electronic means (fees ranging from 1.5% to 3% of the invoice value are charged) and taking steps to regulate unfair fees.
- vii. Completing the digitalization of the services of the Consumer Affairs Authority

#### **4.10 Department of Cooperative Development**

- i. It is expected to initiate projects to establish one-stop cooperative outlets, cooperative agricultural product processing and value chain enhancement projects.
- ii. Rs. 25 million from the Cooperative Development Fund to initiate the project to develop the cooperative outlet network under a unified brand.
- iii. it is proposed to establish 500 production cooperative societies in the second year of the program to establish a total of 1,000 production cooperative societies, which was initiated in 2025 in Sri Lanka.

#### 4.11 Cooperative Employees' Commission

- Updating and revising the Cooperative Employees' Establishments Code, introducing new service conditions relevant to the entire employee community of the cooperative movement, with the participation of the Provincial Cooperative Employees' Commissions.
- ii. Amending the Cooperative Employees Commission Act, No. 12 of 1972, as amended by the Cooperative Employees Commission (Amendment) Act, No. 51 of 1992, to suit the present social and legal conditions.
- iii. Conducting awareness programmes for cooperative employees.

#### **4.12** National Institute of Cooperative Development (NICD)

i. Reviewing the subject content of all diploma courses conducted by the institution as per the needs of the cooperative movement, securing Sri Lanka Qualifications Framework (SLQF) status and starting an advanced diploma course at SLQF-4 level.

- ii. Initiating courses in Tamil medium for officers attached to the Cooperative Development Departments of the Northern/Eastern Provinces and officers serving in Cooperative Societies of those provinces, with the aim of developing the knowledge, skills, attitudes of the cooperative members and promoting inter-member coexistence in those provinces, and taking action to establish a Tamil Medium Studies Faculty within the institution.
- iii. Online registration of students, online learning process and online issuance of results subsequent to the installation of the Learning Management System of the Institute.
- iv. Organizing joint study courses with local/foreign universities.
- v. Organizing joint vocational training courses in collaboration with the Tertiary and Vocational Education Commission.
- vi. Organizing experience sharing programmes enabling other cooperative societies to learn from cooperative societies that have achieved outstanding success in diverse fields.
- vii. Automation and digitalization of the library of the NICD which serves as the knowledge hum of the cooperative sector.
- viii. Organizing English language camps to equip the future generation with entrepreneurship skills to make them better suited to job market.
- ix. Organizing distance education centre courses of the NICD, remotely covering the Western, North Central and Northwestern Provinces.
- x. Establishing and maintaining a digital database that contains data of cooperative societies covering all cooperative societies operating in Sri Lanka.
- xi. Conducting a research study with the aim of empowering production cooperative societies in Sri Lanka to elevate them to export level.
- xii. Establishing a Business Financing Centre. The first step thereof is due to be commenced in 4 multipurpose cooperative societies.
- xiii. Initiating action to establish a permanent pool of external resource persons.
- xiv. Establishing model cooperatives.

#### 4.13 Sri Lanka State Trading (General) Cooperation

- i. The Corporation is currently planning to import rice and maize and distribute essential food items with the aim of stabilizing market prices and the supply of essential food items by importing and distributing essential food items at fixed prices whenever the government requires them in the year 2026.
- ii. Promoting the use of smart boards and other IT devices to improve the efficiency of government institutions in line with the National Digital Policy of Sri Lanka.
- iii. Pursuing action to establish a agency outlet network with the objective of further expanding the marketing network of the entity.

- iv. Making STC brand an attractive destination in line with the demands of the modern competitive market by renovating all external showrooms, including its Navam Mawatha Head Office, to provide a better quality service and customer experience.
- v. Introducing new products to the existing product portfolio with the aim of boosting busiess progress and marketing efficiency of the institution.
- vi. Increasing the turnover of the institution by expanding cash customers in public and private sector institutions.
- vii. To streamline business operations and improve efficiency, a new Enterprise Resource Planning (ERP) system is being implemented. This system integrates core processes—such as finance, human resources, and supply chain management into a single, centralized platform.
- viii. Taking action to obtain ISO quality certification to maintain standardized operational conditions at the institution.

#### 4.14 Food Commissioner's Department

- i. It is proposed to renovate warehouses owned by the Food Commissioner's Department in 2026, using allocated budget funds to enhance the food security program of the government.
- ii. It is proposed to begin operations at a new 5,000 m² temperature-controlled warehouse in Dambulla, which will be used for storing agricultural products. To minimize operational costs, particularly electricity expenses, the facility will be powered by installed solar panels.

#### 4.15 Department of Registrar General of Companies

- i. Renovation of the Department building The approved provision is approximately Rs. 400 million.
- ii. Implementation of the eROC system Version 2 The approved allocation for this is Rs. 250 million. Thereunder :
  - a) Development of the e-ROC system to facilitate stakeholders in accessing information on the ultimate beneficial owners (BO) of companies.
  - b) Developing a common API portal for e ROC interoperability.

  - e) CPD for Company Secretaries Implementation of Continuing Professional Development programs and re-registration of Company Secretaries.
  - f) Linking the e-GP project and the e-ROC project and exchanging information through the system.

- g) Introducing a single form for the incorporation of companies.
- iii. Improving internal departmental network and internet infrastructure.
- iv. Developing and launching the official website of the Department.
- v. Launching a one-day service in January 2026 to provide the department's daily services promptly as needed.
- vi. Conducting joint programmes for the development of capital market.

## 4.16 Sri Lanka Thriposha Limited

It is expected that the company will strengthen its role in ensuring the nutritional security and improving the health of vulnerable children and adults in Sri Lanka through strategic collaboration with the World Food Programme, government support, and internal capacity development, with a focus on sustainable development, innovation, and diversification.
