**Progress Report - 2022** 

#### Word from the Hon. Minister...



It's a great pleasure to present the progress and the performance of the Ministry of Trade, Commerce, and Food Security from January until September, of which the pioneer is the Trade Ministry.

I commenced work as the Minister of the Trade, Commerce and Food Security in May 2022 and since then paid attention and gave instructions and guidence to ensure the delivery of services fallen under the scope of the Ministry to the public in an efficient and productive way for the upmost satisfaction of the general public.

Since the begining of this year a grave escalation is observed in the wholesale prices of consumer items, specially the food items, and accordingly a cabinet memorandum has been submitted as an immediate measure to control this issue. As a result of this, the local importers have been allowed to import selected 10 essential food items (Dry chillie, Sprats, Potatoes, Bombay Onion, Dhal, Wheat Flour, Sugar, Rice, Milk Powder and Gram) under Open Accounts System.

Accordingly the supply of certain consumer items could be ensured at reasonable prices without any shortage, whilst controling the prices of essential items in the market and in the meantime, arrangements were introduced under the Indian Credit Line to import essential food items. Further price control has been applied for the egg market as a measure to maintain a stable price in the egg market. Under such measures, the Ministry could look forward managing the cost of living of people and ensuring food security.

Concurrently to the above measures, the Minisrtry implement steps to direct the functions of the Consumer Affairs Authority to control the inbalance in the market, and to ensure the protection of consumer avoiding shortage of goods and services.

Further a Cabinet Memorandum has been submitted by me to establish Consumers' Setvice Committees to ensure the supply of food items and other essential items without any shortage, to improve the production of local food items, enhance food security, to follow a proper method for the distribution of consumer items and as per the decision of the Cabinet, Action has been taken to establish Consumer Services Committees in every Divisional secretariats.

It is expected by these Consumer Services Committees to promote the awareness of people on nutrition, collect information of the malpractices in the market, inform farmers to cultivate agricultural crops so as not to exceed the requirement, introduce farmers to cultivate crops which can be exported.

Action has been extended through the Dedicated Economic Centers all over the Island to ensure an extensive market for the local agricultural products, deliver vegetables and fruits to the consumers without any shortage, whilst assuring a reasonable price to the farmer. Further action has been taken to establish an appropriate management structure reviewing the existing structure in the management of those Dedicated Economic Centers.

The education and trade exhibition, which was conducted continuously under Lalith Athulathmudali Mahapola Higher Education Scholarships Trust Fund, has been suspended at present and action has been taken to commence it during this year. This exhibition will pave way for the sale of local items, increase the scholarships of the students waiting for university entrance, promoting the products of local entrepreneurs and specially enhancing the knowledge and skills in the field of technology of students.

In addition to the above, action has been taken through the Department of Cooperative Development under the Line Ministry and Department of Cooperative Development under provincial councils to further continue the relevant projects. In the meantime, arrangements have been prepared to launch home garden concept mainly in Colombo and Gampaha districts targeting urban areas before the end of this year using Rs. 100 million from the balance of provisions with a view to enhance nutrion level of low-income people and their income with the assistance of Sri Lanka State Trading General Corporation.

Further action has been taken to review the functions of Lanka Sathosa and Sri Lanka State Trading General Corporation, which are carrying out commercial activities, to maintain them as profitable institutes whilst supplying essential items at a lower price than other supermarket networks.

Finally, I take this opportunity to extend my gratitude to Hon. State Minister of Trade, Hon. State Minister of Rural Economic Affairs, Secretary of the Ministry and State Ministries, Head of Departments and the staff for their commitment.

State Ministers for their guidance in the implementation of these projects and the staff of the Ministry and the Heads of Institutions under the Ministry for their commitment to make our effort a success.

#### 1.1. Vision

"Sustainably Developed Sri Lanka"

#### 1.2. Mission

"Establishing, maintaining, and monitoring a national trade policy in line with local as well as international standards, which ensures the equality and rights of manufacturers, traders, suppliers of measurement services or other services, whilst ensuring leadership in the trade sector, performing service and monitoring activities, obtaining new market opportunities entering in to bilateral, multilateral, and regional trade agreements, contributing to ensure a higher life standard enhancing the quality of consumer items and services of Sri Lankans."

#### 1.3. Objectives

- i. Enhancing the income from exports and aligning the market of Sri Lanka whilst achieving objectives relevant to local and international market based on import and exports to suit to the global trade
- ii. Formulation of policies to ensure the rights of local manufacturers and consumers through the national trade policy.
- iii. Taking action to enhance the exports encouraging productions.
- iv. Maintaining the cost of living at the minimum possible level maintaining the prices of essential items including vegetable, fruit at such occasions where the prices of goods at the markets are escalating.
- v. Providing necessary guidence to implement programmes to the government institutions such as Lanka Sathosa, Sri Lanka State Trading General Corporation in an open market environment.
- vi. Ensuring the application of measurement standards for the benefit of business community as well as consumers.
- vii. Enhancing legal framework with infrastructure facilities to maintain buffer stocks of essential items within the country to assure food security.
- viii. Preparing mechanism to maintain a data base relevant to the institutions under the Ministry, update such data bases, and make links with external information providers.
- ix.Extending legal assistance and consultancy services for the encouragement of exports at national level
- x. Providing guidance to implement the measures relevant to protect the proper standards of local products and export items.
- xi. Making contribution to maintain welfare programs to encourage children for higher education.
- xii. Making directions to implement conservation process for the protection of national intellectual properties
- xiii. Guiding for accreditation services conforming to the national and international standards

- xiv. Establishment of the institutional background and encouragement of connected institutions in order to protect and promote the economic and commercial interests of Sri Lanka and encourage the exporters for opportunities in international market.

#### 2.3. Establishment of Consumer Services Committees at Divisional Secretariat Level

A crisis has arisen in the supply of essential food and essential items due to the economic crisis prevailing in the country. The people of the country are experiencing severe hardships under such circumstance and this may be the cause for malnutrition of the community in future. Therefore, Consumer Service Committees are being established in every divisional secretariat with the participation of Divisional Secretaries covering all over the Island under the direction of the Ministry of Trade Commerce and Food Security in order to provide relief to the consumers. The inauguration of the establishment of such Consumer Services Committees has been held in Ja – Ela Divisional secretarial which chaired by Hon. Minister on 25.10.2022 and accordingly 190 such committees have now been established covering all over the Island.

#### 2.4. Implementation committee for food security

The Committee, which held its meeting chaired by Hon. Minister of Trade Commerce and Food Security under the Cabinet approval, has made recommendations to the Committee for Cost of Living and further coordinated relevant Ministries and institutions for food security whilst providing solutions for the issues arisen in the field. However, this task has now been entrusted to Committee of Food Policy.

#### 2.5. Awareness Programmes

Awareness programmes have been conducted for the benefit of university and school students by the institutions under the Ministry such as Consumer Affairs Authority, National Co-Operative Development Institute, Department of Measurement Units, Standards and Services, and Lalith Athulathmudali Mahapola Higher Education Scholarship Trust Fund regarding their services and ensuring rights of consumers.

#### 2.6. Cabinet Memorandums

By October 2022, Ministry has been taken action to promote trade affairs, food security, protection of consumers, development of Co-operative activities, Higher Education and human resources development and enhance efficiency by way of submitting 47 cabinet memorandums.

#### 2.7. Subsidies on foods and drugs

Subsidies have been granted by countries such as India, Malayasia, and China in the form of food items considering the economic crisis of the country.

#### 2.9. Rice subsidies from China

5000 Mt of rice provided under this stream has been handed over to the Ministry of Education.

#### 2.10. Distribution of food items provided by Madras Rotary Club of India

Divisional secretariats joining with Rotary club of Sri Lanka have distributed food items provided by M.R.C of India among low income families who are recommended by the divisional secretariat

#### 2.11. Subsidies from Malaysia

These aids provided to Dr. Bodagama Chandima Thera have been distributed among low income families identified by Divisional Secretariats and students and bhikkhus who are studding in Pirivenas.

## 2.12. Costruction of a stores complex at Dambulla, which has the capacity for 5000 metric tons under controlled humidity and Temperture for storing vegetables and fruits

Cold stores complex with the capacity of 5000 M.t is constructed at Dambulla area in order to store the excess of potatoes, onion and vegetable produced for issuing them to the market at the season where production is low and encourage local farmer giving maximum value to the producer minimizing post harvesting damages. Physical progress of the constructions is nearly 95%.

#### 2.13. International recognition for the National Measurement Laboratory of Sri Lanka

The measurement capabilities of the Measurement Units, Standards and Services Department as the National Measurement Institute of Sri Lanka has been included for the first time in the data base of Calibration & Measurement Capability (CMC) of the website (<a href="www.bipm.org/kcdb">www.bipm.org/kcdb</a>) at Bureau International des Poids et Mesures (BIPM). It is a great achievement as a country that Sri Lanka has become the second country in South Asia after India, which has been given such recognition. Accordingly, it is certified that the Calibration & Measurement given in the field of trade and other fields by us are recognized at international level.

Therefore, the publishing of our capabilities in measurements in BIPM data base of KCDB marks the first turning point of our journey towards international recognition and accordingly a stamp and a first day cover is due to be issued on 20 May 2023, on which World Measurement Day is celebrated.

#### 2.14. Trade promotion through Department of Commerce

#### i. Recommendation residence visa

Reviewed and recommended 76 expatriates in trading and services sector and 44 of their dependents to the ministry to proceed the issuance of residence visa recommendations.

#### ii. Online system for issuance of certificates of origin

A system has been developed to issue the issuance of certificates of origin by online and further registration of companies and other assisting services were delivered without interruption.

#### iv. Opening foreign market opportunities

- Action has been taken to provide facilities in foreign markets for 25 future exporters of Sri Lanka and further particulars of foreign buyers of spices have been given to the Department of Exports for the preparation of data base.
- Assistance has been provided to 48 institutes for settling issues on exports and imports such as importers of Canada, Japan, United Kingdom, and Pakistan have been introduced to the export companies of Sri Lanka for promotion of productions.
- Step by step the activities (SBSF) process of Sri Lanka Trade Information Portal (SLTIP)
  has been introduced to the business community of Sri Lanka for application it in their
  business.

#### v. Settling issues arisen on foreign markets

Assistance has been given to 48 companies to obtain observations from relevant parties to arrive at peaceful settlements for disputes connected to export and import trade.

#### vi. International Trade Exhibitions and Conferences

Facilities have been made by Commercial Officers who are serving Foreign missions in 10 countries to participate in 12 international trade fairs and conferences for promotion of trade, investment and tourism. Accordingly, opportunities have been provided for Sri Lankan Exporters to improve foreign trade affairs and to obtain opportunities for exports and earn foreign exchange.

#### 2.15. Ministerial Conference of World Trade Organization

The 12<sup>th</sup> ministerial conference of World Trade Organization (WTO) was held in Geneva on 17 June 2022 and at that conference, decisions were taken regarding the following trade issues important to Sri Lanka.

#### • Immediate reaction for insecurity

With a view to lend hand to the countries with food insecurity like Sri Lanka, members of the conference agreed not to impose limits and restrictions on exports for purchase of food items made by World Food Programme (WFP)

#### ullet Releasing right of intellectual property for the production of COVID-19 vaccines.

Giving opportunity to countries like Sri Lanka, which have low capacity to produce drugs, to purchase Covid vaccines at a lower price.

#### • Ageement on Fisherman Subsidies

Granting a concessionary period of two years for removal of subsidies provided to fishermen in the developing countries including Sri Lanka, who catch huge volumes of fish, and occupy in unreported and unmonitored fisheries activities, within their specific regions

#### • Response of WTO to COVID-19 pandemic and preparing for future pandemics

According to this decision, opportunities will be given to provide productive solutions to the countries going beyond the limits of WTO at pandemic situations to face the crisis of balance in payment and food security.

## 2.16. Trade discussions conducted under Free Trade Agreements (FTA)/ Preference Trade Agreements (PTA)/ Joint Committees (JC)

With India and Pakistan two bilateral free trade agreements are implemented. A process has been commenced to conclude OPC under free trade agreement with India. Free Trade Agreement signed with Singapore is being reviewed.

In connection to the activities of Economic Trade Cooperation Agreement with India, Thailand, China and Malaysia are either at study level or exchanging basic documents in this regard. Further the PTA with Bangladesh is at the discussion level.

#### 2.17. Revising Intellectual Property Act

Approval of the Cabinet of Ministers has been granted for the revision of Intellectual Property Act. Accordingly, the second draft bill with revisions of the same has been submitted to the Department of Legal Draftsman and once it is approved also by the Consultative Councils on Intellectual Properties activities pertaining to revision will be completed.

#### 2.18. Approach to MADRID system

Action has been taken to make amendments to the Intellectual Property Act in order to approach the Madrid System governed by World Intellectual Property Organization, which provides facility for registration of local trade marks at international arena. The local as well as foreign applications filed under Madrid System and promotion of foreign investments have contributed for the enhancement in national income.

#### 2.19. Making facilities for registration of Geographical Indicators

Geographical indicators are applied to prove to the consumers and traders that the origin of a material or production in a certain geographical area and their specific qualities, features and goodwill derive from the geographical origin. A special method has so far not applied in Sri Lanka to register geographical indicators in Sri Lanka but only a certification under trademarks has been done so far.

Therefore, it is expected to create a wide market for Sri Lankan productions such as tea, coconut and cinnamon, which have a geographical identity, by way of registering geographical indicators.

#### 2.20. Solving the issue of paying the royalties for artists

A Committee of operation has been appointed by the Minister in Charge of the Subject in year 2021 for determining the royalty to be paid by the media institutions pertaining art pieces used by them in reality shows. Final report containing recommendations is now issued.

## 2.21. Improving Industrial Property Administration System (IPAS), which is the software of National Intellectual Property Office.

After the renewal of the agreement made with Sri Lanka Institute of Communication Technology Agency, commencing the process for including their NIPO IPAS data system in e-cloud and commencing an e-filing method.

#### 2.22. Minimizing the loss of the State Trading (general) Corporation.

The income from operation of the institution has marked an increase by 293% in year 2022 when comparing with the 3rd quarter of year 2021.

When considering as a self-financing institute, it could increase the net profit by 359% even though the operational expenses shows a little increase by 6%.

When the it was highly necessary the intervention of a government institution for importation of rice, State Trading (General) Corporation contributed to control the artificial escalation of the prices of rice by way of importing rice under Indian credit line and selling it at a reasonable price at the market.

#### 2.23. Awarding Accreditation

Accreditation certificates have been awarded by 30<sup>th</sup> September 2020 to 07 Research Laboratories, 03 Medical Laboratories, 01 Calibration Laboratory, 01 research Institute, 01 Production Research Certifying Institute, 02 System Certifying Institutes and the total number of institutes is 15. The income collected by this process is Rs. 54.4 million and 27% out of it is in USD.

#### 2.24. International recognition for accreditation activities

Sri Lanka Accreditation Board is a full member of Asia Pacific Accreditation Cooperation (APAC) and two world accreditation institutes such as International Laboratory Accreditation Cooperation (ILAC) and International Accreditation Forum (IAF).

#### 2.25. Foreign Institutes, which have made inquiries for accreditation

Inquiries have been made by South Asian Countries as well as Middle Asian Countries to get the service of Sri Lanka Accreditation Board and action is now being taken to provide them to service. With the higher demand in this regard, Sri Lanka expect a higher income in foreign exchange.

## 2.26. Utilizing the underground fuel stores of Cooperative Wholesale Corporation, which are so far inactive

In the face of the fuel crisis in the country from March 2022, the distribution of essential goods has been obstructed and action has been taken at that time to repair the underground fuel tanks at main stores of sathosa (Capacity of 32000 L), which were not in use for more than 20 years, and to store fuel from Lanka Petroleum Corporation and then to maintain distribution of essential items using this fuel and obtaining lorries on rental form by Lanka Sathosa Limited.

## 2.27. Opening a Green Sales Center by Sathosa Constructions and Engineering Pvt Limited (Green Super)

Arrangements have been made to facilitate consumers to purchase higher quality items by way of opening a Green sales center (Green Super) at the expense of Rs. 30 million at the ground floor of the Ministry of Trade.

#### 2.28. Super Market at Dambulla city

The land situated at Dambulla city was obtained on long term lease from Urban Development Authority has been granted to Lanka Sathosa on lease to construct a super market with 3800 sqft to the cost of Rs. 23 million and to maintain it with modern facilities using the funds of the institute.

#### 2.29. Modifying the rice processing center at Pannegamuwa

There was a budget allocation of Rs. 50 million for the modification of rice processing center at Pannegamuwa and increasing its capacity, that project could not be implemented as it was required to spent Rs. 35 million for reconstruction of buildings and Rs. 74 million for machinery as a result of the increase in foreign exchange.

#### 2.30. Lanka Sathosa minimizing its loss

Lanka Sathosa could reduce its loss by 53% during the period up to the third quarter of 2022 comparing the previous period.

#### 2.31. Improving Mahapola Scholarship Further

At present Rs. 1,183 million is already spent for 46,320 (for 03 academic years) students who have been selected from all Universities for the scholarship, and it is expected to extend this number by 17,000 spending additional amount of Rs. 434 million in year 2022.

## 2.32. Mahapola Scholarships for the students of Technical Collages and other higher education institutes

The amount spent for the scholarships of 6,000 students of 19 Technical Collages at the rate of Rs. 2,500 per student as one installment, it is expected to spend Rs. 20 million for 1916 students at other higher education institutes.

#### 2.33. Network for purchasing and selling goods

Contribution has been made by the special economic centers to ensure a wide distribution network Island wide building coordination between the producer and consumer. When considering the present economic and social situations of the country, it was observed that the efficiency and productivity of those economic centers should be further enhanced and there is a possibility to achieve this target also.

Further Management Trusts chaired by the District Secretary of the relevant district and representing relevant parties have been established for the management and administration of the 13 special economic centers, which are already functioning, and 05 centers to be established.

## 2.34. Making consistency guideline compulsory for the business community who carry out business online.

The majority of consumers had to rely on ordering their goods through internet under the situation that arose in year 2020 due to Covid-19 pandemic, therefore with a view to formalize this sector, a guideline has been prepared with the assistance of International Trade Center for the benefit of business community who carry out their business through internet. Accordingly, these guidelines have been altered by a committee which consists of officers and specialists of the field to suit to the Sri Lankan context. Programmes have been organized to make the business community using internet and then the draft guideline has also been submitted to them. The approval of the Board of Directors has been granted to these Guidelines, which has been improved considering the suggestions of them.

#### 2.35. Registering the business community, who carry out their business online

Under section 27 of the Consumer Affairs Authority, pilot project has been initiated at the Divisional Secretariat, Ja-Ela for registering business community and the registration process was carried out as planned.

#### 2.36. Committee of Specialists for quality assurance and certification

In order to avoid the violation of the rights of consumers due to the poor quality of foods and non-food items, further to certify the standard and quality of foods and no food items, and also to protect the rights of consumers, it was decided to appoint a committee consisting of specialists from the Ministry of Trade, Ministry of Health, Consumer Affairs Authority, National Medicines Regulation Authority, Industrial Technology Institute, University of Moratuwa, University of Sri Jayewardenepura, and Institute of Chemistry.

Further the understanding on the market is highly necessary for the price decisions taken by the government and also to bring the enthusiasm of business community at optimum level. Therefore, the necessity for the establishment of Pricing Forms for essential goods and services, which determine bearable prices and ensure stability of the business, has been identified. Accordingly, action has been taken to establish a committee for pricing in order to use the knowledge of veterans and to take decisions on process based on data.

#### 2.37. Amending the Consumer Affairs Act.

The first phase of amendments of the Consumer Affairs Act No. 09 of 2003 has been completed and they have been approved both by the Department of Legal Draftsman and Afforneg General's Department. These amendments are due to be tabled at the Parliament in November 2022.

#### 2.38. Human Resources Development of the Cooperative field

The National Institute of Cooperative Development, which is the leading institute for the human resource development of the said field, has taken action to enhance the capacity of human resource conducting various courses spending the funds of the institution.

# **Chapter IV**

# 2023 - Action Plan

#### 4.1 Ministry

#### i. Maintaining a buffer stocks of essential food items and their distribution

An allocation of Rs. 15,000 million is expected for maintaining buffer stocks of foods in order to manage urgent requirements with the direct intervention of the government assuring accountability on food security and avoiding shortages of quality foods in the market for satisfactory of consumer's needs.

## ii. Coordinating the implementation of consumer services committees at the level of Divisional Secretariat

Objective of this measure is to make the rural community aware of the behaviors of market, send productions promptly to the market, strengthening the links between consumer and the manufacturer

## iii. Completion of the works at Tharampuram Cooperative Village Project -Rs. 688 million

Completion of the remaining work of these buildings without delay are planned get in to action to hand over to suitable institute for maintenance of services.

#### 4.2 Department of the Commissioner of Foods

- i. Constructions of humidity-controlled stores complex at Dambulla Rs.149 million.
- ii. Distribution and clearance of food items given to the country by World Food Programme.

- viii. Conducting workshops for building a project for Intellectual Property Environment System in order to expedite innovations and commercialization of intellectual properties at local and international levels.
- ix. Strengthening further the mechanism applied of payment of royalties to the creators of songs, and other musical creations played in electronic media.
- x. Obtaining Lanka Government Cloud facility to National Intellectual Property Office of Sri Lanka

xi. Actually, participation in external exhibitions and promotional programmes.

#### 4.6 Sri Lanka State Trading (General) Corporation

- i. Provide facilities to attract a number of buyers from both public as well as private sectors and minimizing the expenses of the institute as far as possible in line with the policy of government for minimizing expenses whilst ensuring maximum results from expenses.
- ii. Popularizing the name of STC among people by way of brand promotion which is one of the main targets of the 5-year plan.
- iii. Introducing goods suit to the timely requirements, which are identified by market researches, to the market under STC brand and ensuring their sale.
- iv. Minimizing the operational expenses of the institute as far as possible in line with the policy of government for minimizing expenses whilst ensuring maximum results from expenses.

#### 4.7 Sri Lanka Accreditation Board for Conformity Assessment

#### i. Digitalizing the accreditation process

It is expected to commence the digitalizing process in 2023 in line with the policy of the government to enhance the productivity of public services. Main objectives of this project are to minimize the time in the service delivery, ensure more benefits to the recipients by way of minimizing expenses such courier charges, stationary etc.

## ii. Widening the scope of accreditation to cater to the buyers of foreign countries and assist the testing laboratories.

Action is taken to widen the scope of accreditation of the laboratories, which has the capacity, in order to ensure parameters and testing reports to the exporters. This measure will pave way to minimize the time taken for issuing reports and the cost of testing.

## iii. Widening accreditation schemes of institutes to assist industries and obtaining international recognition

It is planned to enhance the capacity of service delivery in 2023 for the benefit of proficient testing providers (PTP). This will help to the testing laboratory to participate in the proficient testing programmes provided by proficiency testing providers in Sri Lanka, who have obtained international recognition through mutual recognition agreement. (ILAC MRA).

#### 4.8 Lalith Athulathmudali Mahapola Higher Education Scholarship Trust Fund

i. To assist, to establish and to manage the higher education institutes with a view to provide opportunity for youths to enhance their vocational and professional education, which is indicated under provision 05 of the objectives in Mahapola Scholarship Trust Fund Act No. 66 of 1981. With a view to achieve above mentioned goal, action has been taken to establish new universities and new technological universities and it is expected to provide opportunities to local students, who have had qualifications for university entrance at

- G.C.E. A/L, for obtaining a foreign degree in Sri Lanka and further to increase foreign exchange and minimize the outflow of money by opening universities for foreign students on recovery of charges for their education. Initiatives in this regard have been made in year 2022. It is expected to bear full expenses for the infrastructure facilities of the project by Mahapola Fund.
- ii. Promotional programmes have been prepared in order to obtain contribution to the fund from those who have completed their education under Mahapola Scholarships. It is expected to launch this programme from January 2023. It is expected to use sprinted and electronic media as well as social media platforms such as YouTube and Facebook. The expectation of such measure is to enhance the Mahapola Fund by adding additional contributions.
- iii. Mahapola Education and Trade Exhibitions

Conducting at district level the education and trade exhibition for the awareness of school children and trading community. Participation of institutes under the Ministry and trading community is to be obtained in this regard.

#### 4.9 Consumer Affairs Authority

- i. Taking action to avoided releasing unhealthy items to the market.
- ii. Making standards to ensure the health safety of consumer items.
- iii. Ensuring reasonable pricing method for goods and services to protect the rights of consumers.
- iv. Conducting awareness programmes for business community, school and university students.
- v. Amending the Act of Authority in order to strengthen legal provisions further.
- vi. Rs. 9.25 milion for the implementation of digital services management system

#### 4.10 Department of Cooperative Development.

It is expected to implement programmes as purchase and sale of rural productions joining with Cooperative Societies for uplifting rural economy, programmes for enhancing agri seeds production, programmes for centralized ordering and distribution by way of making a network with institutes connected with the Department.

Promoting the export of productions made by members of Cooperative societies and modifying Cooperative shops.

#### 4.11 Co-operative Employees Commission

Amending the Co-operative Employees Commission Act No. 12 of 1972 amended by Act No.51 of 1992 with a view to ensure more productive monitoring process for stability of Co-operative movement and enhance to human resource in the field.

#### **4.12 National Cooperative Development Institute**

- i. Taking action to commence degree programmes on Cooperative management.
- ii. Opening a language training center.
- iii. Improving the existing syllabuses considering the timely requirements and focusing mostly for practical activities.

- iv. Launching programmes for sharing experiences.
- v. Making necessary innovations to obtain NVQ levels for selected courses.

#### 4.13 Co-operative Development Division

- i. Introducing a new software to the Cooperative field and thereby ensuring high quality service to consumers and managing it by a one system and engaging Co-operative societies under one network.
- ii. Establishment of School Co-operative Societies.
- iii. Establishment of Youh Brigades' Co-operative Societies.
- iv. Directions of selected Co-operative Societies, which have focused on export-oriented businesses to new fields

#### **4.14 Dedicated Economic Centers**

- i. Restructuring the management trusts which has established relevant to special economic centers increasing representation of farmers' community of farming areas and providing necessary guidelines in this regard.
- ii. Preparing a combined management process by building a proper coordination among special economic centers of the Island whilst performing the management and administration of special economic centers further by the management trusts established at such centers.
- iii. Implementing a joint programme with public and private participation in order to enhance further efficiency of the operations of special economic centers whilst ensuring a wide network of distribution.
- iv. Identifying and implementing a wide programme with the coordination of district officers and political authority of the area in order to use special economic centers, which have been constructed with building and infrastructure facilities but not yet opened. More productive way to suit to the special requirements of the area and present economic and social conditions.

#### 4.15 Projects which are implemented under foreign aids

#### i. United Nations Industrial Development Organizations

This project is proposed to be implemented in order to enhance food production, food safety, and quality in the agricultural sector with the provision of Euro 6500 during the period from 2021-2024.

#### ii. Project for strengthening infrastructure facilities qualitatively in Northern and North Central province of Sri Lanka

Implementing the phase two of the project for strengthening quality services of Sri Lanka using aids of Euro 0.8 million during the period from 2019-2023.

#### iii. Digitalizing intellectual properties

This project is implemented with the contribution of the World Intellectual Property Organization (WIPO) and Intellectual Property Office of Sri Lanka using allocation of Rs. 90 million under technological and financial aids of WIPO during the period from 2022-2023.
