The supply of rice faced to a decline before the lapse of one month after establishing our Government as the recent Governments had not regulated the market based on correct data. However, we were able to settle these issues in the market by way of importing rice through Lanka Sathosa and State Trading Corporation, the institutions under our Ministry.

A Government should maintain buffer stocks in order to ensure food security within the country. Otherwise, the consumers would be the victims of several large-scale businessmen as it is happening now. Therefore, the Ministry and the Paddy Marketing Board have decided to maintain a buffer stock of rice from Maha Season of year 2025.

The policy of our government is to cultivate all the crops, which can be cultivated within the country. Nearly 1,600 USD million has to be spent annually for the importation of foods. We are expecting to save 40%-50% from this amount during the coming year. For this purpose, the 1000 Production Co-operative Societies to be commended in 2025 will be immensely helpful ve this target. In the meantime, programmes are now being prepared to provide value added productions to the international market through the Department of Commerce under my Ministry. In addition to expanding the sales network of Lanka Sathosa, action will be taken to establish wholesale trade centers in several selected districts by way of reactivating SATHOSA. Further, the mechanism is being strengthen to formalize the moving of qualitative goods in the market by strengthening Consumer Services Authority. We, as a Government, are now making efforts to create era of renaissance in the true sense of words eradicating corruptions and introducing modern technology. Therefore, I believe that your contribution will be ensured to make our efforts for offering you a modern life in a rich country in each and every way a success.

Message of the Secretary ...



Main role of the Ministry of Trade, Commerce, Food Security and Co-operative Development is to ensure maximum contribution for the enhancement of the living standards of Seri Lankans conforming to the policies of the Government. Accordingly, the Ministry has already taken a large number of measures to safeguard the rights of both trading as well as consumer communities whilst providing them facilities in the meantime providing directions to the sectors such as trade, commerce, food security and co-operative development, and ensuring maximum contribution for the food security, monitoring and regulating. Our target is to create a fair and competitive approach to the market for producer and

consumer whilst enhancing the quality of trade and commerce sectors, establishing, ensuring and regulating a national trade policy in line with local and international trade policies,

With the intention to achieve this target, the Ministry has ensured its maximum intervention during the year under review to provide goods and services with high quality at a fair price by way of maintaining the network of relevant institutions connected to the fields such as trade, commerce, food security and cooperative development. However, it is highly critical to find sustainable solutions for the prices escalation and shortages of goods due to Island economy, adverse climates and market imbalances often observed in the global market. In the meantime new strategies should also be introduced in this regard. Therefore, year 2025 can be highlighted as a year which marks a new turning point. The Ministry has established a Committee for Food Policies and Security aiming at the food security and it is working actively under the Ministry of Trade, Commerce, Food Security and Co-operative Development and Ministry of Agriculture, Livestock, Lands and Irrigation.

Further, it is expected to operate the Department of Commerce to conduct international trade exhibitions, awareness programmes with trading community with a new approach to enhance international trade links, whilst expanding new market opportunities through international trade agreements and combined commissions turning to enhance the foreign exchange. Facilities are to be provided for the promotion of small and middle scale entrepreneurs as exporters to achieve this target.

Initiatives have been taken to launch programme for the establishment of 1000 co-operative societies aiming specially at productions and digitalizing the functions of National Intellectual Property Office of Sri Lanka , Consumer Affairs Authority and Department of Measurement Units, Standards and Services. In the meantime, it is planned to modify further Laksathosa and network of co-operative shops to provide essential goods at a fair price, and expand the functions of SATHOSA and State Trading Corporation enabling direct importation. Under this context, action will be taken to restructure and reactivate SATHOSA to ensure the food supply chains under the Government.

I take this opportunity to extend my heartfelt gratitude to Hon. Minister and two Deputy Ministers for their directions and guidance to make these efforts a success and further the staff of our Ministry and Heads of Institutes under Ministry along with their staff for their commitment to make the mission and vision of the Ministry a reality.

1.2. Mission

"Establishing, maintaining, and monitoring a national trade policy in line with local as well as international standards, which ensures the equality and rights of manufacturers, traders, suppliers of measurement services or other services, whilst ensuring leadership in the trade sector, performing service and monitoring activities, obtaining new market opportunities entering in to bilateral, multilateral, and regional trade agreements, contributing to ensure a higher life standard enhancing the quality of consumer items and services of Sri Lankans.'

1.3. Objectives

- i. Applying custom tariff policy as a tool for controlling the market behavior so as to secure the rights of local producers and consumers through a national trade policy and encouraging exports by way of granting tax concessions to local producers in order you induce productions.
- ii. .Maintaining the cost of living at the minimum possible level maintaining the prices of essential items at such occasions where the prices of goods at the markets are escalating
- iii. Providing necessary guidance to implement relief programmes for the benefit of consumers through the government institutions such as Lanka Sathosa, Co-operative Development Department, Co-operative Societies and Associations etc. at national level in an open market environment
- iv. .Ensuring the application of measurement standards for the benefit of trading community as well as consumers
- v. Enhancing legal framework with infrastructure facilities to maintain buffer stocks of essential items within the country to assure food security.
- vi. Providing guidance to the Consumer Affairs Authority for the legal activities relevant to safeguard consumer
- vii. Preparing mechanism to maintain a data base relevant to the institutions under the Ministry, update such data bases, and make links with external information providers.
- viii. Providing guidance to implement the measures relevant to protect the proper standards of local products and export items.

 - x. Making directions to implement conservation process for the protection of national intellectual properties.

02. Specialties

2.1 With a view to provide essential food items to consumers at a reasonable price and without any shortage, Consumer Affairs Authority was constantly instructed and directed and action was taken to provide assistance to consumer checking the quality of the goods were checked for controlling unfair trade practices, declaring maximum retail and whole sale price at necessary instances in order to provide consumer items at a bearable price and without shortage, and removing such prices considering the necessarily. Information pertaining to the imposing of retail and wholesale prices are given below.

- 2.2 Approval has been granted to import rice by private importers without obtaining import permits under the approval of the Cabinet in order to prevent the sale of rice at higher prices and avoid the shortage of rice in the final quarter of year 2024 and accordingly, nearly 83,215 MT of rice has been imported during the period from 02.12.2024 to 31.12.2024.
- 2.3 Action has been taken to import 70,000mt of Nadu Rice through Sri Lanka State Trade Corporation and Lanka Sathosa under the approval of the Cabinet in order to ensure food security and accordingly 780 MT of the above has been imported by 31.12.2024 by Sri Lanka State Trading Corporation and distributed through Lanka Sathosa and Co-operative Societies and Super Markets. Orders have been placed for importing another stock of 25,200 MT.
- 2.4 A special programme has been launched to sell rice and coconut to the consumers at a reasonable price by Lanka Sathosa network as a remedy to the shortage occur in local market during the last period of year 2024. Accordingly, Lanka Sathosa has purchased nearly 4.5 million kilograms of imported rice during the period from December 2024 up to 15 January 2025 and nearly 1.5 million kilograms out of the above has been sold. In the meantime, nearly 13 million kilograms of local rice has also been sold during the time from September 2024 up to 15 January 2025. 893,442 coconuts have been purchased during December 2024 and 726,285 out of the above have been sold.
- 2.5 With a view to protect local farmers, action has been taken to submit recommendations and proposals to the Department of Trade and Investment Policies on import tarrif for imported essential food items depending on the situation. Ex. Potatoes, Big Onions, and Canned Fish.
- 2.6 Procurement process has been commenced obtaining the approval of the Cabinet on 18.12.2024 to import 30,000 MT of salt, to which Iodine has not been mixed, by State Trading Corporation considering the facts submitted by Salt Producers' Association regarding a possible shortage of salt in the future market.
- 2.7 Granting approval of the Cabinet at its meeting held on 01.07.2024 for the establishment of National Quality Council for planning, organizing, coordinating and promoting activities connecting to the implementation of National Quality Policy
- 2.8 Taking action to refer all the representations on the issues and grievances of manufacturers, traders, and consumers to relevant institutions for getting solutions and providing necessary directions.
- 2.9 Getting approval for the Cabinet Memorandum declared on the regulations under the Intellectual Property Act No 36 of 2006 for the registration of Geographical Indicators.
- 2.10 Taking action to suspend with immediate effect the future action as per the Cabinet Paper No 24/1712/627/001-1 dated 02.09.2024 on the liquidation of CWE when assuring the contribution of the state in market operations in order to ensure welfare of consumers, food security, provision of facilities to farmers and small and mediumscale entrepreneurs as per the policy framework of the Government and making plans for restructuring and utilizing CWE for operations.

2.11 Taking action as per the Cabinet Paper No /24/2338/817/005 dated 30.12.2024 to alienate following stores to the CWE, which managed by Regional Development Bank and Peoples Bank making capacity for CWE to purchase and store paddy in Maha season 2024/2025.

II. Implementation of development projects and programmes

a) Tharapuram Co-operative Village project

Approval has been given to take action as mentioned in sub para 3.1 para 3 of the Cabinet Memorandum referred on 11.03.2024 as per the Cabinet Paper No 24/0503/627/011 dated 01.04.2024 given for the future works of this project. Accordingly, it has been proposed to turn this to a suitable project through National Agency for Public Private Partnership (NAPPP) under the Ministry of Finance, Planning, and Economic Development with a view to continue this project suspended. Even though Rs. 54 million has been allocated in the budget of year 2024 for this project, it could not be carried out as a result of the issues arisen in making payments.

Accordingly, discussions have been conducted with NAPPP in this regard as per the instructions given by the Cabinet. However, action is now being taken to submit a new cabinet memorandum on the future works of the project as that proposal has not been implemented.

b) Southern Development Project

Even though an allocation of Rs. 87 million has been made by budget provisions for settling the bills of this project in year 2024, payments could not be made even by 31.12.2024 as there were certain issues. Accordingly, action is now being taken to take a cabinet decision for referring them to relevant Ministry to make payments pertaining to these bills and files.

c) Amalgamated project for food security (Rs. 250 million)

Even though the project has been prepared, it has to be suspended the works of the project temporarily due to the letter dated 01.08.2024 sent by the Election Commission under Elections Law.

d) Project for uplifting low income women entrepreneurs for food security (Rs.100 Mn) Rs. 6.5 million has been paid to State Trading Corporation for the works of the project.

This project has to be suspended temporarily due to the letter dated 01.08.2024 sent to the Ministry by the Election Commission under Presidential Elections Law.

III. Establishments activities

- a) The interview for recruitment to the post of Director of Lalith Athulathmudali Mahapola Higher Education Scholarship Trust Fund has been conducted on 12.09.2024 and Schemes of Recruitments to the approved posts of Lalith Athulathmudali Mahapola Higher Education Scholarship Trust Fund have been prepared.
- b) Taking action to prepare regulations under registration of geographical indicators under Intellectual Property Act of Sri Lanka. Action has been taken to obtain approval of the Cabinet for amendments, which should be made to the Intellectual Property Act in order to have the access to Madrid Agreement, which provide facilities to register local trademarks internationally.
- c) The report of the committee appointed to make recommendations for restructuring the Consumer Affairs Authority established by Consumer Affairs Authority Act No. 09 of 2003, enabling to achieve expected objectives has been submitted to the Consumer Affairs

Authority on 18.0-4.2024 and guidelines have been given accordingly by way of making recommendations on changes to be made under each division.

- d) The revised scheme of recruitment relevant to the posts of Assistant Measurement Units and Standards Services Officer and Measurement Laboratory Testing Officer of the Department of Measurement Units Standards and Services, has been referred to Public Services Commission for its approval and further action has been taken to appoint a committee to amend Measurement Units and Standards Services Act No 35 of 1995.
- e) Proposals have been made by the Food Commissioner's Department for reviewing the staff approved for the Department and accordingly a report has been prepared identifying the staff required in the process for restructuring the Food Commissioner's Department as per the Cabinet Decision dated 12.08.2024 reviewing the proposals submitted.

IV. Formulation of the National Trade Policy

Based on the views of the reviewing committee by 11.08.2023, the second draft of the trade policy has been prepared in 2024 and it has been submitted for the review of the Export Promotion Division of the Presidential Secretariat. Having reviewed the draft of the concept paper prepared by this Ministry, it has been submitted to the United Nations Trade and Development Organization.

V. National Evaluation Policy of Sri Lanka

In terms of the Project Management and Monitoring Circular 01/2024 on 'Responsibility and role of all public institutions for the implementation of the National Evaluation Police of Sri Lanka', proposals were called for the evaluation of projects in order to get the provisions allocated by the budget of Government in the financial year of 2025.

- a) Accordingly, stores complex with the facilities to store Agri productions of 5000 mt with necessary temperature, of which constructions are concluding, has been submitted to project evaluation programme and approval of the Department of Project Management and Monitoring has been obtained.
- **b)** Provisions required for that evaluation programme have been allocated by budget 2025 under Department of Project Management and Monitoring.

3.2 Department of Commerce

I. Multilateral Affairs Division

a) World Trade Organization (WTO)

The 13th Ministerial conference of the World Trade Organization has been held at Abudabi from 26 February to 1st March 2024 and multilateral discussions were held there on the trade issues.

Sri Lanka has joined with G 33 and other developing countries on matters such as Agricultural discussions and agreements for assistances to fishermen and further

supported the formulation of flexible policies to protect the rights of the fisheries community in special economic zones.

In the meantime, the Hon. Minister conducted bilateral discussions with the Minister of Trade of Israel and further, joined with the discussion of scholars, which paid attention to the assistance provided by the Advisory Center on World Trade Organization Law (ACWL) hosted by WTO.

The final review of the trade policy of Sri Lanka, as a member, was conducted in 2016 and the next review is due to be held on 15 -17 October 2025. For this purpose, The Department has provided comprehensive information coordinating relevant institutions (Ministries, Departments, Boards, etc.) to the questionnaire sent by WTO to commence the works of the report of the General Secretariat.

Discussions with Uzbekistan for an approach to WTO -Since Sri Lanka is interested in the export of tea to Uzbekistan the, Department along with the Sri Lanka Tea Board has concluded discussions between Sri Lanka and Uzbekistan for Uzbekistan's approach to WTO obtaining International Normalized Ratio (INR) for black tea.

b) Activities on the representation of Sri Lanka in WTO (World Trade Organization) /EU (European Union /FAO (Food and Agriculture Organization) /IFAD (International Fund for Agricultural Development) /WFP (World Food Programme)

Sri Lanka has joined 69 multilateral discussions on Agriculture, Trade Facilities, assistance for Fishermen, WTO reforms, and trade and development fields to protect the country's requirements in bilateral discussions. It has made preparations for the 13th Ministerial Conference of the World Trade Organization conducted in Dubai in UAE the and the 5th review of trade policies in 2025 and it includes other main activities for participation.

Joining with the committee discussions of the WTO, Mission of Sri Lanka to the UN Geneva has made 43 written and oral interventions paying attention to the matters such as food security, agriculture, fisheries assistances, issues on development etc. In addition to the above, 25 group discussions and bilateral discussions have been made to continue the necessities of Sri Lanka.

Provision of facilities to build technical assistance and development skills-

Sri Lanka has advantages from several training programs and workshops aimed at the skill development of public officers on trade policy, services trade and agreements of WTO such as **sanitary and phytosanitary measures** agreement. With the assistance of organizations such as the International Trade Center (ITC) and UNCTAD (UN Trade and Development), the Mission of Sri Lanka to the UN Geneva has assured 12 short - term and long - term training programs for officers of Sri Lanka.

Bilateral promotional activities - Providing assistance to make a survey on the opportunities for Sri Lankan business in Switzerland, this Mission has made facilities for 14 business inquiries on the export of spices and processed foods. In addition to the above, 11 promotional programs have been held including the efforts for reforming Swiss-Sri Lanka Business Council and WTO Open Day.

Remarkable achievements - Promotion of the requirements of Sri Lanka and enhancing capacity for the implementation of WTO agreements in the decisive trade discussions are included in the main achievements. Collaborative efforts with UNCTAD and ITC have created an environment for progress in the development of the trade policy of Sri Lanka and the implementation of the WTO trade facilities agreement. Marking the main step of a process being implemented in 2025, these discussions were concluded by joining with Uzbekistan and it was highlighted as a remarkable moment.

c) Trade Facilitation Agreement (TFA)

In terms of the decision taken at the quarterly meeting of the National Trade Facilitation Committee (NTFC) held at the Presidential Secretariat under the chairmanship of the Ministry of Finance in June 2023, 01st and 02nd quarterly meetings of NTFC have been conducted.

WTO (World Trade Organization) has been informed of the completion of several sections pertaining to TFA before the closing date. They are Consultations 2:2, exempting custom tariff and other charges from final decision 7:3, and post clearance audit 7:5, etc.

Assistances on capacity building and technical assistance has been provided in 2024 by ADB and World Bank to NTFC. World Banka provided assistance for the management of risks and the Asian Development Bank provided assistance to formalize custom procedures.

Necessary information and assistance have been provided as a member of Project Implementation Committee (PIC) to the Project Implementation Unit established under the Ministry of Finance for directing the NSW project.

d) Implementing trade remedy laws

Department of Commerce has finalized the basic regulations for the commencement of investigations on imposing anti-progressive and alternative taxes and they were sent to the Ministry of trade, Commerce and Food Securities. Accordingly, Department of Commerce has drafted operational guidelines and internal circulars required for the investigation process.

e) Investigations initiated by other countries against the producers/exporters of Sri Lanka

Investigation on imposing anti-progressive and alternative taxes on the importation of paper file covers from Kampuchea and Sri Lanka has been initiated by the Department of Commerce of the United States of America on 12 November 2022 (USA-DOC).

A Review of the anti-progressive measures taken on importations of bicycles from China the by European Union commenced on 29 August 2024 and it has been a remedy extended up to the goods imported from Indonesia, Malaysia, Sri Lanka, and Tunisia. Therefore, exporters of Sri Lanka are also parties to this review. The transition review of the United Kingdom on imposing anti-progressive and alternative taxes has been commenced on 23.08.2024 against the importation of bicycles and certain their spare

parts from Sri Lanka, Kampuchea, Indonesia, Malaysia, Pakistan the Philippines and Tunisia.

The Department of Commerce of Sri Lanka has held several rounds of discussions with parties of the Sri Lankan Government and producers on these investigations. Since this investigation is based on the allegations of avoiding anti-progressive and alternative taxes imposed on bicycle productions from China to the European Union and the United Kingdom, the Department of Commerce has informed the Bicycle producers and exporters of Sri Lanka regarding the methods for participating in this investigation.

Providing instructions on the issues of trade remedies The Department has provided instructions to the Board of Investment on the possible investigations on trade remedies by the USA and other countries regarding several factories on mattresses and solar modules proposed to be invested in Sri Lanka. Further, The Trade Remedy Unit of the Department of Commerce has researched the risks and situations that may arise due to possible trade remedial measures by other countries and opportunities for investments in those fields by Prawn Processing and solar panel industries and the industrial sector of Sri Lanka.

f) Technical Assistance

Two workshops at a national level have been conducted with the resource persons of WTO. The First workshop was conducted in February 2024 on the agreement on the measures to be taken for the plants and animal health of WTO and second workshop has been conducted in July 2024 on the trade facilitation agreement and its future within Sri Lankan context. Nearly 60 persons representing both the public as well as private sector have participated in these workshops.

Assistance has been provided in November 2024 and March 2024 to FCAU (Food Control and Administration Ubitof the Ministry of Helth) of the Ministry of Health on the CLDP (Commercial Law Development Program) program under the Department of Commerce of USA for participating in SPS committee meetings of WTO on the measures to be taken on plants and animal health

During the tour of the representatives of the Asia Pacific region of ITC (International Trade Center) in May 2024, capacity building program supplied by the World Bank in respect of several selected parts of TFA (Trade Facilitation Agreement) to obtain technical assistance were coordinated for the institutions responsible for implementing implement TFA.

Sessions conducted to make awareness of the Fisheries Assistances Agreement of WTO were coordinated including officers of the Ministry of Fisheries and Department of Fisheries and Aquatic Resources and experts of WTO.

Proposals have been prepared to obtain technical assistance under Advance Rulings with the coordination of Sri Lanka Customs and ITC for the preparation of the proposal to be submitted to the TFAF (Trade Facilitation Agreement Program) of WTO.

II. Bilateral affairs division

a) Australia and Sri Lanka Trade and Investment Framework Arrangement – Quarterly meetings of the working groups

Two quarterly meeting of the working group established under the Trade and Investment Framework Arrangement-(TIFA) between Sri Lanka and Australia have been held in May and October 2024. The action plan prepared by both parties paying attention to the investments, agriculture and knowledge sharing has been brought to the discussion table. Accordingly, it was said that considerable progress is seen in technical assistance for mining projects and agricultural projects.

b) Working group of Europe- Sri Lanka trade and economic collaboration

A meeting of the working group of Europe - Sri Lanka trade and economic collaboration has been held online on 06 February 2024 with the participation of the representatives at higher level. Development of economic and policy development, problems in bilateral market approaches, regulatory developments of the European Union including regulating forest destruction, GSP scheme, and assistance for trading activities were among the matters discussed at the meeting. At the meeting of the working group, Sri Lanka highlighted its main policy interventions to establish economic stability in the country. In the meantime, the European Union has highlighted the features of the new GSP system which is on the discussion table. Further, both parties have discussed several fields relevant to potential cooperation including the settlement of issues about certifications for market approach and technical assistance required for the regulatory compliance. When settling issues about to trade and establishing an environment friendly for strengthening bilateral economic links in the future, both parties approved the importance to continuing productive dialogues in the future.

The progress of the meeting of the working group has been reported to the 26th EU-Sri Lanka Joint Commission on 22 February 2024.

C) Inter-Regional Accumulation Facility for the exportation of garments using Indonesian fabrics under EU GSP (Generalized System of Preferences) scheme

A sound decision has been taken by European Commission on 09 July 2024 for the combined application prepared by Sri Lanka and Indonesia for granting eligibility for custom tariffs under EU GSP scheme for the production of certain textile and garments fallen under HS chapter 61,62 and 63 of HS using Indonesian textiles fallen under HS chapter 51-58, 58 and 60 aiming the EU region. This concession will remain until both countries are considered as beneficiary countries of GSP.

d) Developing Countries Trading Schemes of United Kingdom (DCTS)

Sri Lanka became a beneficiary of UK DCTS in 2023. When items are exported to the UK under DCTS, Sri Lanka is involved in a process for submitting an application joining with Indonesia to obtain concessions of custom tariff for the items produced using Indonesian textiles.

e) 12th session of the Combined Commission for economic collaboration between Sri Lanka and Iran

Preliminary meetings were held on the session to be held with the stakeholders of Sri Lanka and line Ministries and dates have been proposed to Iran for holding the 12th session in the third quarter of 2024. However, this session has been postponed up to the 2nd quarter of 2025 due to the elections to be held during that time.

f) Development Collaboration between Sri Lanka and China under One Belt and One Road Initiative

Recommendations/ proposals have been given to the Ministry of Finance by the Department of Commerce in connection to initiating the One Belt One Road concept of China considering the importance of China as the major trade partner of Sri Lanka. Having considered the technical aspects of Free Trade Agreements, the Department of Commerce proposed that it is important to treat discussions on Trade Agreements and the One Road One Belt concept separately.

g) Updating the progress under Combined Commission between Sri Lanka and Maldives

As a part of the effort made constantly to enhance bilateral trade relationships between Sri Lanka and Maldives, the Department of Commerce has concluded its review of the Terms of Reference for the proposed Joint Working Group on Trade between Sri Lanka and Maldives. These observations have been submitted to communicate to relevant authorities and it has marked a significant step towards the establishment of JWGT (Joint Working Group on Trade) aimed at strengthening trade and economic collaboration between two countries.

h) Inter state commission on Trade, Science, and Technological collaboration between Sri Lanka –Russia

Department has provided its observations on the proposed Customs Collaboration Agreement between the two countries with the assistance of Si Lanka Tea Board and they have been distributed among relevant stakeholders.

i) Bilateral political consultations and other bilateral provisions

During the period of review, inputs on trade and economic relationships have been provided by the Department for the bilateral political consultations given to following countries by the Ministry of Foreign Affairs. United Kingdom, Switzerland, Turkmenistan, Bhutan, Germany, Estonia

Recommendations /proposals have been provided by the Department for the revision of the draft of the proposed Memorandum of Understanding (MOUS) for the establishment of combined working group on trade investment and production chain between Sri Lanka and Dominican Republic.

j) Joint Commission on Trade and Economic Collaboration (JCTEC) between Sri Lanka and Egypt

A discussion has been held at the Department of Commerce between line Ministry and stakeholders of Sri Lanka as a part of the preparations for the 3rd session of the Joint Commission.

k) Joint Commission on Economic and Technical Collaboration between Sri Lanka and Turkey

Proposals were called from stakeholders for calling the 3rd session of the Joint Commission on Economic and Technical Collaboration between Sri Lanka and Turkey

1) Free Trade Agreements at the level of discussion

Discussions on free trade agreements have been coordinated by the Office for International Trade – (OIT) during the period under review with India, China and Thailand and further discussion have been coordinated on preference trade agreements with Indonesia, and Bangladesh. Whilst holding the posts of Chairman, Co-Chairman, and member of the sub committees, Officers of the Department have provided all required reports and technical inputs including trade of goods, laws on sources of origin, SPS, TBT, trade remedies, service trade and collaboration among customs to relevant committees.

III. Regional Affairs Division

a) Working Group on Trade and Investment (WGTI) of the Indian Ocean Rim Association (IORA)

Sri Lanka Participated in the 23rd meeting of the Working Group on Trade and Investment (WGTI) of the Indian Ocean Rim Association (IORA)held online on 27 November 2024. At the meeting, the representatives discussed the implementation of an action plan for WGTI, and a strategic discussion was held with the participation of a resource person of UNCTAD on the role of trade and investment and the stability of the supply chain.

As the Chairman of IORBF, the Sri Lanka Chamber of Commerce has joined with the Foreign Ministry of Sri Lanka the conference of businessmen of the Indian Ocean Rim Association under the theme 'Sustainable Growth-Limits' at Shangrila Hotel from 28,29 May 2024 at Colombo.

Main objective of the Business Conferences to enhance the dialogue, networking and collaboration among business leaders, policy makers and stakeholders of selected 12 fields of 23-member countries of IORA such as agriculture, information and communication technology, supplies, renewable powers, tourism, small and middle scale entrepreneurs and women empowering. There were 300 participants at this occasion covering representatives.

b) Free Trade Agreement of Bay of Bengal Initiative for Multi-Sectoral Technical and Economic Cooperation (BIMSTEC)

Custom tariff concessions of HS 201/7 are prepared again for releasing trade under FTA/PTA for reviewing trade releasing program under BIMSTEC free trade zones as

per the Cabinet decision dated 08.02.2021. It was proposed to hold the 22nd meeting of the Trade Negotiation Committee and the 22nd meeting of sources of origin laws (WG-ROO) (Working Group on Rules of Origin) by BIMSTEC secretariat on 18, 19 September 2024.

c) Step-by-step activities of Sri Lanka Trade Information Portal

The Step-by-step process means additional involvement to enhance the user-friendly approach of the present Sri Lanka Trade Portal. Under this, 49 and 06 export productions and import productions have already been noted and it provides export and import information on export and import procedures to interested businessmen.

During the awareness session organized by the Sri Lanka Exporters National Board and National Commerce and Industries Board, step-by-step processes, trade procedures, and their implementation and benefits included in the Sri Lanka Trade Information Portal were introduced to trade stakeholders.

d) Sri Lanka Trade Information Portal

"Cyberia" means a company located in Lao. It has been made maintained and hosted on SLTIP up to the end of January 2022. The Calling of IFQ for hosting and maintaining has been concluded by the Department with the assistance of the Department. Under the bidding system, quotations have been called from 11 companies (Provided by ICTA). Out of 03 companies which that have submitted bids to be implemented with effect from 15.11.2021 (One-year contract) Arimac Lanka Private Limited has been selected by the Department and ICTA hosts for Lanka Government Cloud -LGC free of charge. Then the service period of Arimac Lanka Pvt Ltd has extended the service period by another one year up to 31.12.2023. Later data transition activities and training for the SLTIP administration website were carried out by Cyberia company. The Department continuously updates SLTIP with 42 representatives of stakeholders.

e) Preparation of trade report

Nearly all trade summaries/reports on trade have been prepared and updated in comprehensive and combined level depending on the requests made by various outside parties during the period under review.

IV. Trade Promotion Division

a) Taking action on trade inquiries

481 trade inquiries have been received by Commercial Officers and publicize productions of Sri Lanka in foreign market necessary information and directions were given. 45 inquiries made to the Department by exporters and other institutes involved in the trade have been referred to Commercial Officers for follow up action.

b) Providing assistance for settling trade disputes

45 complaints have been submitted requesting observations from the parties involved in the dispute connecting to import and export with a view to reach a peaceful settlement. Department of Commerce intervenes as a facility provider for settling import and export trade disputes by reaching a peaceful settlement for the dispute. During the period under

review, foreign missions of Sri Lanka have dealt with 57 complaints and necessary action has been taken for 28 complaints directly submitted to the Department of Commerce.

c) Making recommendations for residential visas

Letters of recommendation have been issued for visas after reviewing 57 foreigners and 30 dependents in trade and services sectors.

d) Trade Ratio Quota Certificates issued for garments with India under ISFTA No of - 2,195 TRQCs have been issued for shares of 6.8 million.

e) Approving Loan Providing Institutions under the Mortgage Act of 1949

In terms of the powers vested under section 114 (i), a committee consisting of 3 members is to be appointed to make recommendations to the Director General of Commerce on Loan Agencies for publishing them in the Gazette as Approved Loan Agencies.

f) Issuing letter to give up custom tariff for Basmati rice quota under free trade agreement between Sri Lanka and Pakistan

Under the free trade agreement between Sri Lanka and Pakistan, 24 letters for removing custom tariffs are issued to import 966 MT of Basmati rice under the Sri Lanka Pakistan Free trade Agreement.

g) Organizing trade exhibitions/ exhibitions / ceremonies

- i. The Group of Representatives for 8th China- South Asia was organized by the Department of Commerce and 106 companies were included and the Head of this was the Secretary of the Ministry.
- ii. All Island awareness sessions have been organized by the Department of Commerce for the benefit of small and middle scale exporters and a new theme has also been introduced—"Trade Up Sri Lanka." With the assistance of 45 public and private business institutes and with the participation of more than 400 in small and middle scale business divisions, the inauguration ceremony was held in the Matara district on 26 June 2024.

h) Representation of foreign Commercial Agencies

During this period, a summary of the activities performed by Commercial Officers, who are abroad, is given in the following table.

b) Online system for issuance of certificates of origin

A project has been launched for further development of the existing ECOO system for the issuance of electronic COOs with the financial and technical assistance of DOC, ITC and GIZ, action has been taken to solve the gaps in the system and add new features. This project has been launched under the context of COVID-19 and it is expected by the system to find solutions for the challenges faced by exporters, formalizing and expediting the supply of COOs and other supportive services.

2024 The Following activities have been completed under ITC and DOC project's

- i. LPOP facility linked with Commercial Bank, Peoples Bank, Pan Asia Bank, and Cargill Bank provides the experience of an enhanced online payment path to exporters for ECOO.
- ii. Requirements of recipients were shared with Information and Communication Technology Agency of Sri Lanka (ICTA) and ICTA has allocated recipients' space on the Lanka Government cloud.
- iii. The Software Development Company has made necessary enhancements to the live system and matrix. A New mechanism has been made for Areca nut exporters under a quota system introduced by the Department of Export Agriculture with the Department of Commerce and the electronic facility has been interconnected with the Department of Export Agriculture. .Now the Department of Export Agriculture can enter the ECOO system to supervise and update the annual Arecanut quota.
- iv. Awareness programmes have been conducted all over the year to enhance knowledge on the implementation of ECOO for existing and new exporters
- v. DOC company registration, reviewing process, training on COCOs approvals and issuing, and cost statements/ affidavits reviewing have been concluded.

vi. Issuance of ECOO under ISFTA (The India-Sri lanka Free Trade Agreement), SAFTA (The South Asian Free Trade Area), SAPTA (The SAARC Preferential Trading Arrangement) and APTA (The Asia-Pacific Trade Agreement) Agreements in 2024, saving 93% of the time, enhancing a paper free environment, and total digitalization.



ii. Progress of the tasks carried out using international relationships

Department of Measurement Units Standards and Services holds associate membership of Bureau of Weights and Measures, (BIPM) which is the leading institute of all over the world on scientific measurements, and full membership of the International Organization of Legal Metrology (OIML). Further, it holds full membership of Asia Pacific Metrology Programme, which is a regional organization on measurement science and the Department has been offered the post of Chairman for the second time for 2024 of DEC- Developing Economies Committees. Further, the Executive Officers of the Department of

Measurement Services Standards and Services make a significant contribution to the task force established there.

At present, Department of Measurement Units and Devices takes action in relation to the following projects.

a) Projects of the United Nations Industrial Development Organization (UNIDO)

Mainstreaming Standard based best practices for Agri – Food sector development project (BESP).

The New project of UNIDO is implemented from 2023 to 2025 and it provides infrastructure facilities for strengthening food security and protection of foods of Sri Lanka. Department of Measurement Units Standards and Services actively participating as a main stakeholder of this project. This project provides training, consultation services, and equipment for the National Measurement Laboratory as foreign aids for the development of measurement.

b) Asia Pacific Regional Project for Metrology – Enabling Developing Economies in Asia (MEDEA)

Physikalisch-Technische Bundesanstalt (PTB) has been commenced in May 2021 MEDEA 3 for activating developing economies in Asia and it will be continued up to 2025. It is aimed by this project to assist to the sustainable development goals of United Nations in targeted economies and this project will provide contribution for activities and training activities related to building capacity in various fields of measurement science.

The committee of the Developing Countries of Asia Pacific Metrology Programme (APMP-DEC) performs activities of this project by now.

Providing a service with higher quality for National Measurement Laboratories of Sri Lanka by way of obtaining international recognition.

Accreditation for number revision laboratory has been obtained from 28 December up to know to three parameters on length (up to gauge block -100 mm $_{\xi}$, measuring ruler-2000 mm, Rule calibrator -2000 mm) ISO17025:2017. On receipt of that accreditation, it will issue number revision certificates with ISO 17025: 2017accreditation with international recognition for gauge block and measuring rulers out of consumer number revisions of technical division.

Reviews of Specialists relevant to number revisions of external micrometer for range between 0 to 25 have been concluded and now it is waiting for ISO 17025:2017 accreditation offer from Sri Lanka Accreditation Board for Conformity Assessments. In addition to this, maintaining accreditations obtained by laboratories on pressure and volume with necessary updating.

It has planned to commence the process required for number revision facilities to the fields and to prepare methodologies for number revision of equipment used in the field of Infusion Pump/Syringe Pump joining with volume and pressure laboratory of this Department. This task is carried out under PTB (Physikalisch Technische Bundesanstalt) – MEDEA (Metrology – Enabling Developing Economies in Asia) project. For this purpose, contribution as resource providers is made by National Measurement Laboratory of Thailand.

- iii. Taking action to formulate a common lease agreement for all economic centers on issuing business places on lease.
- iv. Taking action to settle the issues on the ownership of the land where the economic Centers are located.
- v. Taking action to widen composition of Management Trust of Economic Centers.
- vi. Making essential development activities of Economic Centers.

ii. Main activities carried out in 2024

a) Launching initial works for digitalizing files on intellectual properties

This is a service facility given free of charge for the development of business services at Intellectual Property Office under bilateral agreement proposed between World Intellectual Property Office and Intellectual Property Office of Sri Lanka. It could make initiatives to make agreements in 2024 for the commencement of this project.

b) Satisfying basic qualifications for entering in Madrid Protocol

It could obtain approval of the Attorney General with the concurrence of the Legal Draftsman and World Intellectual Property Organization to make necessary revisions to the Intellectual Property Act for entering in the Madrid Protocol, which provides facilities for registering trademarks internationally. Accordingly, the matter has been referred for the submission of Cabinet Memorandum.

c) Providing facilities for the registration of geographical indicators

No special methodology was available so far in Sri Lanka for the registration of geographical indicators in Sri Lanka and only it has been registered as a certified mark under trademarks. It could publish the regulations drafted for the implementation of law for the registration of geographical indicators in the Gazette with the signature of the Minister

d) Participating in foreign training, programmes and workshops on the subject of intellectual properties

It could direct 10 officers of the institute in 2024 for 12 foreign training, programmes and workshops on the subject of intellectual properties.

A turnover of Rs. 8.18 billion has been reported in 2024 and the gross profit earned during the year is Rs. 986 million.

ii. Profit before tax

The Corporation has earned Rs. 455 million in 2024 as the profit before tax.

iii. Special operations in 2024

a) Widening the range of productions

State Trading Corporation of Sri Lanka acts as an importer and distributor whenever it is necessary to balance the supply and the pricing of the market in the face of a shortage of food items. Accordingly, when there was a shortage of eggs in the market, under the direction and of the Ministry of Trade Commerce food security it managed properly this situation by way of importing stocks in order to distribute them through the network of Lanka SATHOSA. Further action was taken to import and distribute Undu, Dhal to settle the shortage in the market.

Under the direction of the Government, action was taken to import and distribute yellow wheat as an animal food.

Cloths for uniforms of school students and Sri Lanka Army have been imported with the assistance of the Government.

During 2024 Smart Boards has been promoted and it became a new production added to the range of information technology productions of the institute.

b) Employees' Development

With a view to enhance the efficiency of operations, attention was paid for the personal and professional development and by March 2024 it could maintain a labour force of 300 in the Corporation.

c) Strategic initiatives

Action has been taken to improve the range of productions by way of introducing new productions and marketing programmes have also been launched to enhance the income of existing productions.

d) Administration and compliance

During year 2024/2023, 13 meetings of the Board of Directors and 04 meetings of the Audit and management Committee have been conducted.

3.13. Department of the Commissioner of Foods

Construction of the temperature controlled cold stores complex, Dambulla

The construction works of this project has now been completed 98%. Payments have been settled for the amount of Rs. 21.4 million, which has been born by Urban Development Authority for the development of the land in order to take over the land, where the project is carried out. Action pertaining to take over the land is being carried out. It is proposed to carry out operations of the project by a Board of Management and it is proposed that the Board of Management should carry out operations of the stores complex with the collaboration of both Public and Private sectors. Rs. 382 million will be required for the completion of constructions and management and operations in year 2025.





Chapter Four

2025 – Future Plans

04. 2025-Future Plans

4.1. Ministry of Trade, Commerce, Food Security and Co-operative Development

- i. It is expected to establish a large-scale rice mill with modern facilities in Anuradhapura district within 02 years spending Rs. 10 billion.
- ii. It is expected to implement small and middle scale rice production project with the expense of Rs.200 million under the project to ensure food security and strengthen women entrepreneurs by selected women, who are the beneficiaries of Aswesuma and registered Farmers' Organizations.
- iii. Taking action to use the roves of store complexes under the institutions of Ministry for solar panel projects.
- iv. Anti-Dumping and Countervailing Duties Act No 02 of 2018 and Safeguard Act No 03 of 2018 have been enforced and it is expected to declare the regulations for the promotion of production economy and inform the same to World Trade Organization. In the meantime, it is expected to establish a separate unit in the Department of Commerce.
- v. Since there is no act in wide range to control the international trade affairs, it is expected to formulate an international trade law with a legal framework for the promotion of export-oriented industries and goods and services.
- vi. Revision of the Companies Act No 07 of 2007 to make the registration of shareholders more convenient.
- vii. Revision of Consumer Affairs Authority Act No 09 of 2003 to formalize internal trade affairs and protect the rights of consumer conforming to the present economic and social conditions of Sri Lanka.

4.2. Department of Commerce

- i. Department has planned to turn for awareness programmes at regional level within the year.
- ii. It is expected to obtain more assistance under ITC 'USA/CLDP' for development of trade.
- iii. Department of Commerce plans to organize 3 B2B promotional programmes in order to promote selected export-oriented industries. This project is to be launched with the collaboration of Ministry of Industries, Sri Lanka Export Development Board, National Chamber of Commerce, and other stakeholders of public and private sectors.
- iv. As per the orders/ directions of the Government Department of Commerce participates in bilateral, regional and multilateral trade discussions.

4.3. Lanka SATHOSA Limited

- i. Opening 150 New Lanka SATHOSA sales centers Main objectives of these measures are to getting closer to consumer and providing essential goods at the minimum price through management of distribution cost and negotiating prices for purchase by way of widening sales centers network as per economic theory whilst enhancing income of the institute.
- ii. Establishment of new combined Entrepreneur's Resources Plan system (ERP). Lanka SATHOSA, which is a major competitor in the modern market field, needs a highly credible and efficient combined entrepreneur's resources plan system. Therefore, it is expected to establish a timely new combined Entrepreneur's Resources Plan system (ERP)

which links all sales outlets, stores, and Head Office for the decision-making process. It is expected to avoid situations such as under and over stocks, turning return of stocks to zero or minimum level.

iii. Recruitment of qualified employees with skills.

Employees with skills, who have been recruited on casual basis, have been recruited in 2024 as permanent employees and the positive effect made by the motivation gained them by such act is considerable.

- iv. Direct purchases from Farmers
 - It is expected to provide essential items to consumers at a minimum price as there will not be space for intermediaries and in the meantime a market will be created to the farmer.
- v. Enhancing additional income.
 - The only way for our institute, which plays in a competitive market, is to enhance additional income to gain a higher profitability.
- vi. It is expected to have a growth by way of conducting a special audit at every sales center, identification of new opportunities, reassessment of prices, and increasing them. It is expected to enhance additional income by restoring joint business plans with main suppliers.
- vii. Enhancing gross profit margin.
 - It is expected to gain the whole profit by way of enhancing percentage of gross profit margin negotiating with suppliers.

4.4. SATHOSA

- i. Commencing wholesale trade with new face restructuring SATHOSA and reconstructing 10 stores under SATHOSA
- ii. Re-launching Hingurakgoda and Pannegamuwa rice mills belonging to SATHOSA and commencing their processes.
- iii. Opening 03 wholesale shops of SATHOSA have been opened in Matara, Colombo and Kurunegala for selling food items at wholesale prices.
- iv. To purchase paddy all over the Island subject to a maximum limit of 300,000 mt purchasing paddy as a joint effort of Paddy Cultivation Board, SATHOSA and Co-operative movement and allocate Rs. 50 million to repair existing stores to store paddy.
- v. Maintaining the business of Sathosa transport service, security service and Engineering service etc. With a new face and reopening the fuel shed of SATHOSA.
- vi. Taking initiatives to import directly essential food items by SATHOSA.
- vii. Establishing 150 new Lanka Sathosa shops in the year 2025, increasing the 448 shops up to 1000 within 03 years and as a result of this, it is possible to make bulk imports and supply item to the shops.
- viii. Possibility to control market prices as a result of issuing essential food items at a reasonable price by way of importing them to Co-operative network.

4.5. Lalith Athulathmudali Mahapola Higher Education Scholarship Trust Fund

- i. It is expected to pay installments of Mahapols scholarships to 17000 students of the academic year 2022/2023 during the year.
- ii. Commencing online Mahapola Scholarship Library
- iii. Government has decided to increase Mahapola Scholarship from Rs. 5,000 to Rs. 7,500 and therefore, it is expected to collect resources to Mahapola Scholarship fund in order to ensure the financial stability of the fund. For this purpose, launching online Mahapola Lottery Scheme, establishing old boy's association for giving opportunity to past beneficiaries of Mahapola Scholarship.

4.6. Sri Lanka Accreditation Board for Conformity Assessment (SLAB)

i. programme for digitalizing accreditation process

At present, Sri Lanka Accreditation Board for Conformity Assessment has already completed the digitalizing process of tasks of laboratories. It is planned to implement digitalizing process for tasks connecting to all other accreditation schemes. With the implementation of this scheme, Sri Lanka Accreditation Board for Conformity Assessment has planned to reduce cost for operations and enhance efficiency in its service delivery.

ii. Introducing promotion and brands for accreditation

Sri Lanka Accreditation Board for Conformity Assessment has planned to implement a promotional program on official approval in connection with the 20th anniversary. It has planned to implement a series of programmes during the year paying attention to General Public, monitors, Accreditation Institutes, and other relevant public institutes.

iii. Taking action to widen accreditation services provided by the institute whilst introducing new accreditation programmes.

Sri Lanka Accreditation Board has planned to launch new accreditation schemes in 2025 for biobanking (ISO 20387) and ISO/IEC 17034 Raw materials producers.

iv. Taking action to expand capacity development programmes

In addition to the training calendar of the year, Sri Lanka Accreditation Board for Conformity Assessment has planned to conduct special capacity building schemes for the local and overseas participants, which are under attack.

v. Establishment of National Quality Council

Establishment of National Quality Council for introduction of qualitative concept and practices in the public sector in line with National Quality Policy. For this purpose, approval of the Cabinet has been given under /24/1148/627/021 dated 10.07.2024.

4.7. Department of Measurement Unit, Standards and Services

- Establishment of central air condition system at National Measurement Laboratory. -Rs. 555 million has been allocated for phase I from Measurement Units, Standards and Services Fund
- ii. Widening the role of the National Measurement Laboratory establishing new measurement standards such as Power, sound and volume.
- iii. Enhancing the course on measuring science of the training division of the Department up to NVQ vi level- Estimated amount is Rs. 490,800.
- iv. Taking action to include measurement science as a subject for university education.
 University of Colombo Course IA 4301 Precision Measurement techniques and calibration of instruments
 - University of Vavunia Course EN 541 (II)3 Metrology course
- v. Updating Measurement Units Standards and Services Act and Regulations.
- vi. Formulation of Measurement Standard Management Information System- Estimated amount is Rs. 70 million. It is expected to join 25 district offices with the Head Office and assure a correct and credible measurement service to the consumers by formulating trade data system.

It is expected to implement these projects using the funds of institution.

4.8. Dedicated Regional Economic Centers

With a view to operate regional economic centers in a more productive way, taking action under aids from Korea and construction of 05 small and middle scale temperature controlled cold storage facility to store potatoes, onion, and fruit at selected economic centers

4.9. Intellectual Property Office of Sri Lanka

- i. Providing online facility for payments and submission of applications.
- ii. Making facilities for the registration of geographical indicators.
- iii. Amending Intellectual Property Act for entering Madrid Protocol.
- iv. Performing functions of Intellectual Property Office under smart methods.
- v. Enhancing Industrial Property Administration System (IPAS), the software system of National Intellectual Property Office up to level 4.
- vi. Implementing digitalizing project using funds of World Intellectual Property Office (WIPO) and formulation of Intellectual Property Policy to carry out tasks of Intellectual Property Office of Sri Lanka in more effective and efficient way.

4.10. Consumer Affairs Authority

- i. Measures for the protection of consumers and producers
 - With a view to protect consumers and producers, it has been decided to introduce following regulatory measures.
 - Regulating the compulsory issuance of machine printed invoices to consumers and producers
- ii. with breakdowns for the identification of cost and tax component of purchased items separately.

For this purpose, regulations have been declared to order to issue an invoice generated by machine inclusive of cost, taxes and other charges separately to consumers establishing Point of Sales machine (POS) at all businesses or trading institutes which have registered for value added tax.

When a consumer makes payments by his/her electronic card, number of trading institutes, canteens and restaurants recover a charge from 1.5% to 3% from the invoice value in addition to the value of invoice, such practices make barriers to the digital payment systems. Therefore it is proposed to regulate the recovery of such unauthorized charge.

In order to protect both consumers and producers from the above issues, suitable regulatory measures will be taken by Consumer Affairs Authority, and Central Bank of Sri Lanka.

iii. Implementing a project spending Rs. 140 million from the fund of institute for digitalizing functions of the institute, whilst making activities of Consumer Affairs Authority more convenient, and with a view to ensure consumer friendly service delivery.

4.11. Department of Co-operative Development

- i. To commence the programme for the establishment of 1000 production co-operatives covering all Divisional Secretary's Division in order to implement the policy manifesto of new Government
- ii. Implementing handloom and power loom textile, dried fish and mushrooms and paddy banks with the investment of Rs. 25 million.
- iii. Implementing an amalgamated programme for purchasing paddy
- iv. Amending Co-operative Act No 05 of 1972.

4.12. Co-operative Employees' Commission

- i. Implementing a salary revision for employees of Co-operative sector.
- ii. Conducting awareness programmes for Co-operative Employees.
- iii. Implementing scheme of recruitment and scheme of promotion of co-operative employees with necessary updating.
- iv. Preparing disciplinary procedure to suit to current needs with updating.

4.13. National Co-operative Development Institution

- i. It has planned to conduct 04 consultative programmes, 01 training programme, 08 diploma courses, 04 certificate courses, 45 short term courses and the total number of participations expected is 1852.
- ii. Obtaining Sri Lanka Qualification Guidelines (SLQF) status reviewing syllabus of all diploma courses conducted by the institute to suit to the requirement of the institute and commence a higher diploma at the level of SLQF-4.
- iii. Automating and digitalizing the library of National Co-operative Development Institute, which is the knowledge hub of Co-operative sector.
- iv. Establishment and maintenance of Digital Co-operative Societies Data System covering all co-operative societies of Sri Lanka.
- v. Conducting a research study to enhance the Production Co-operative Societies of Sri Lanka up to export production level .
- vi. National Co-operative Development Institute expects to commence short term, middle term and long-term courses covering relevant scopes or legal, financial, accounting related to co-operative institute including co-operative societies and take action to safeguard customers,

- recipients and co-operative movement and to look forward from 2025 as an institute with economic stability.
- vii. Inclusion of the knowledge on Co-operative Movement in school syllabus and taking action to make the teachers aware in this regard.
- viii. Taking necessary action to upgrade Co-operative Development Institute to the level of University

4.14. State Trading (General) Corporation

- i. Importing and distributing essential food items whenever the Government wants to make the supply essential foods and the market prices stable and importing rice and salt to satisfy the needs in 2025.
- ii. Expansion of the promotion of smart boards, and other information technology productions conforming to the digital policy of the Government.
- iii. Purchasing a land and constructing a store for explosives using Government funds as the capital.
- iv. Implementing a new enterprises resources planning system
- v. Modifying and reconstructing the showroom at Nawam Mawatha like other building and premises of the area and making that place an attraction of the consumers.
- vi. Opening two new showrooms widening the network of showrooms of the Corporation
- vii. Achieving an additional growth in the sales by introducing new productions to the existing range of productions
- viii. Enhancing the turnover by extending the consumers base to the institutes of public and private sector.
- ix. Future Plan of the institute
 - It is expected to continue its expansion to new batches of productions and markets using the strength at maximum level to assist to make the content of the policy manifesto of new Government a reality (A Thriving Nation Beautiful Life) in order to contribute to the development of national economy.

4.15. Department of the Commissioner of Foods

- i. Transforming the Temperature Controlled Cold store constructed at Dambulla under the supervision of the Food Commissioner's Department to operational level.
- ii. Implementing the programme for modification of store complex belonging to the Food Commissioner's Department
- iii. Making plans to earn an additional income by fixing solar panels on the roof of the buildings belonging to the Food Commissioner's Department

4.16. Department of the Registrar of Companies

- i. It is expected to modify 04 floors of the building "Samagam Medura" and to invest Rs. 150 million for such modifications and essential development activities.
- ii. It has planned to invest Rs. 32 million from the funds of the institute for vehicle repairs, development of office equipment and institutional affairs.
